

What is the difference between “being Saved” and “given Life”.

I felt I had to write this piece after speaking to many people who through worldly Christian teaching had been utterly confused, and thus believe that these future qualities amounted to the same thing for ‘good Christians’. But The Bible distinctly uses them very differently, because they mean and refer to totally different things – that is why they are different words, and why Jesus Christ (JC), together with the apostles used these words specifically to explain separate applications.

Jesus Christ (JC) spoke by saying (paraphrasing):

1. I have come to **save** The World (being Greek to mean “the adornment/decoration” – humans).
2. Those humans who do what I say will have **life**.

Now worldly Christian teaching muddy the waters by joining the two statements together to achieve a beguiling set of quotations:

“Believe in JC and you will be saved!”

“Believe in JC and you will have life!”

Feeling justified because they would quote Acts.16v31 to defend their stance!

Actually the worst possible thing than an outright lie is a half truth, because you must understand your subject matter pretty thoroughly to decipher where ‘the truth’ ends and ‘the lie’ starts.

The practice of speaking in half truths (as per the two worldly Christian quotations above by taking things out of context) is a standard practice used by Satan as we read in Genesis when he spoke to Eve. In Matthew/Luke when he spoke to JC in the three temptations and further when Peter thought he was doing a good thing by trying to dissuade JC from going up to Jerusalem.

At the end of this piece I will carefully extract “The Truth” from “The Lie” part of both those quoted statements in pandemic use by the leaders of worldly Christianity who thus clearly demonstrate they are ignorant of their subject matter. “Ignorant” to mean that while they ‘know’ their subject matter ‘they do not understand it’ – and thus “blind” because they cannot apply what they know – thus not spiritually wise – hence foolish!

So what did JC mean in his first statement?

“I have come to **save** The World.”

By the definition of the Greek word used for “The World” means “The Adornment/Decoration of the planet”.

Thus JC is speaking of all life on this planet – but in this context he is speaking of mankind.

Thus JC is saying: “I have come to **save** mankind.” But the most important thing is that he places no qualifiers on that statement. Thus by default JC has saved every single person in mankind over the last 6000 years.

But “saved” from what?

The Bible tells us that we are “under a death sentence” and as such ‘a slave to Satan’.

Yahweh’s Decree has never been repealed, nor shall it ever be repealed (for an eternity):

“In the day you sin, you shall (begin to) die (everlasting).”

Thus when we die = we are ‘dead’, which means ‘utterly unconscious’. The Bible does not speak of ‘a soul’ as some type of ‘consciousness’ that ‘floats off into the ether’ – and as we are errantly told by our very worldly Christian leaders floats off to the heavens.

The reader must also beware that when the word “soul” is used in Bible translations, the ‘worldly translators’ also translate the word “life” for exactly the same Greek word “psuche” (Strong’s = 5590). The translators in error deliberately switch and change the meaning as they personally deem fit to continue ‘the mystique’, being the pretence that there is something that is still left – to perpetuate “The Lie” that Satan said in the Garden of Eden that: “Eve would not die (if she disobeyed Yahweh God)” when The Almighty God (Yahweh) distinctly said: “she would die!”

I explain in my Glossary (in www.FutureLife.Org) precisely what The Bible logically means by “psuche” in scientific terms – please see “Soul”, “Life”, “Heavenly Treasure” and “spirit” as good starting places.

The Bible tells us that when we die, we are dead – and thus not in a state to even realise we are dead.

I also explain exactly what is occurring elsewhere in detail (please see my essay on “What is a soul”) but in a synopsis:-

It can be likened software and hardware:

The brain’s synapse construction (being a precise mapping) created/moulded by our thought processes during our life (now becomes two part because of Jesus’ Ransom Sacrifice) can be retained by Yahweh as a ‘bit mapping’ of the connections and strength/weighting of those synapse connections. This is stored like software on an HD DVD and we are told by The Bible that this mapping information is retained by Yahweh safely in the heavens as our “heavenly treasure”.

Just as humans are able to load ‘the application program’ (software) onto a ‘new virgin computer’ (hardware) to make it then function and operate (= ‘think’ = be ‘conscious’) then likewise Yahweh can do the same at our resurrection.

Just as the computer hardware is dead without its ‘application software’, and then likewise the application software is dead when it has no ‘computer hardware’ to operate within.

Thus the two parts become alive when operating together.

This is an identical situation with humans, now (the synapse construction being formed during our life), at our death (they separate – both now become individually useless = lifeless = dead) and then at the future resurrection (where Yahweh as the external Facilitator brings the two parts together – consciousness then ensues – The Bible calls this “Awakening/Roused”).

Thus until JC came to give his ministry and then The Underserved Gift (= The Ransom Sacrifice) being his Selfless Act of offering his life for the rest of mankind (= his personal creation). He was not forced to – he could have walked away at any time, and further, not even volunteered to leave his perfectly safe spiritual body in the heavens to enter a very unsafe corruptible fleshly body to give his ministry and early death for all of mankind. Yahweh is The Righteous God, sets the Laws of The Universe and thus cannot be seen to break or twist His Laws. For Him to be The Pinnacle of Righteousness then He cannot be seen by any entity in The Universe to break or bend laws – else He becomes ‘changing’ and thus ‘flawed’.

The Bible clearly tells us that Yahweh is “not changing”, nor are His Laws, nor His Standards - because He is ‘The Pinnacle of Perfection’ and once at perfection, anything else is imperfection!

So how is Yahweh able to be righteous and yet save The Culmination of Jesus Christ’s Creation being ‘the human race’ from everlasting death (being the power of Satan’s death sentence over all of us) = utter annihilation for each one of us when we die?

We know now from what The Bible tells us, that there is no = zero ethereal ‘soul’ (and thus not some human consciousness wandering around in the ‘afterlife’). So we are able to understand that worldly Christian leaders promote a lie being Satan’s Lie of deception that he gave to Eve in The Garden of Eden – contrary to what God tells us in The Bible. I am most desirous for the very best worldly religious scholars/leaders to espouse their errant ideas on this one so that I may publicly dissect and thus publicly examine on this website their myths against what The Bible specifically tells us!

So continuing:-

It is only (and this cannot be over stressed) through the sacrificial death of JC in a fleshly body that the resurrected JC now safely back within his heavenly/celestial/spiritual body (termed JCg) is able to offer on an exact like for like basis a resurrection for each and every person that lived. Yahweh is able to righteously (before all entities) use His Holy Spirit power (being His expressed Desire in action) to reconstruct by DNA amplification an utterly new fleshly body ready to download the stored synapse mapping within. We are given an illustration of this in Ezekiel with his prophecy of “The Valley of the Dried Bones” (principally directed for the New Spiritual Israel).

But there are significant ‘strings attached’ to this wonderful act that JCg has done for us, which I will explain later.

But as we have seen, this wonderful act is for every person that has existed, whether they have heard about JC to believe upon him or not – there is no (= zero) differentiation or demarcation (religion, creed, colour, nationality, ethnic grouping, or whatever – no distinction – all shall be resurrected irrespective of what they have done). Thus just as JC stated in his ministry:

“I have come to save The World (= all humans from their 1st death)”.

Because of what JC did for us, Yahweh is now righteously/equitably (before His Decree) able to store the synapse mapping (created by our thought processes) and use this information to recreate the exact clone of ourselves. We will think so alike to our previous selves that we will, precisely as The Bible tells us, believing ourselves just to: ‘have gone to sleep and woken up in the morning’, and thus remembering the things we did the very day before we died - as though it were yesterday (I explain elsewhere how this operates for those people with Alzheimer’s or the equivalent disabilities). For all intentions and purposes we are exactly the same person – except we will be operating in a perfected DNA body with any imperfections removed and having all the DNA self correcting and repair functions fully operational (being what is now termed Junk DNA correctly functioning again as it was in the created Adam and Eve). As I state elsewhere The Creation (human) was based upon previous humanoid designs that did not have a perfected DNA frame, nor could they think, reason (on morality) and recognise ‘A Deity’. Hence as The Bible distinctly tells us “Let us create man (= humans) in our own image (= having the ‘non animal’ qualities that we recognise as human and the ability to recognise our Creator Deity)”.

Thus as The Bible distinctly tells us, JC in context put no over-riders, caveats, conditions on the statement that he came to save ‘The World’ - thus the statement is applicable to every single human who has existed during the last 6000 years.

Now what about JC’s second statement?

“Those who do what I say will have life.”

JC also said something else that was most important, covered in Mark.12v30-31 where he gave The Two Laws that are to drive the thought processes of the human brain.

Just as an old eastern proverb says: “The body follows the mind.”

JC was getting the thought processes accurately aligned so that humans could then fulfil The Law of Moses and be righteous in Yahweh’s sight. As we are told JC did **not** come to take anything from The Law (of Moses) but fulfil it in his actions that were driven by his thought processes. And these two laws that he gave out to The World drove his thought processes to enable him to succeed = to be perfect.

And he told us: ‘provided we listened’ and ‘did what he said’ then we would have **life**.

Paul the later apostle said: “Copy me as I copy JC”.

And what were these two Laws?

1. Love Yahweh with all your fortitude (= commitment), mind, heart and life/soul (“psuche”).
2. Love your neighbour as yourself.

I explain elsewhere precisely what both of these mean to a responsive person.

But essentially it means throwing away your old worldly lifestyle having evolved to (vainly) succeed in the present world (under Satan’s rule of selfishness) and putting on a new personality (that is being nurtured by Yahweh’s holy spirit ready for The Millennium). This new personality must be nurtured and grown by the person within themselves, being an embryo based upon Yahweh’s Holy Spirit working within you (being the concept of “generation”, being the whole process of being ‘Born Again’ – but ‘birth’ has **not** yet occurred – except for JCg [Rev.1v5]) – See Glossary.

This has occurred because you have metaphorically heard “JCg knocking at the door” (being a True Christian {= TC} offering to speak to you about ‘The Good News’), “you then open the door to JCg” (by listening to this information being given to you by the TC). “You then have supper with JCg” (by reading The Bible and having further conversations with the TC to gain more understanding) at which point JCg will start to dispense Yahweh’s Holy Spirit (= HS) within you because JCg now has a **presence** within you (Rev.3v20). Thus you are now watching, gaining oil (= working) for your lamp (= preaching Yahweh’s Word) as a faithful virgin (= not tarnished with Satan’s World) and thus is able to see The Bridegroom come at the 1st 2nd C – this is what The **Presence** and The **Coming** of JCg in The Bible really means. This HS is given for you to nurture and make grow. This is the new personality that you must take on-board. You must leave the old worldly mentality/personality and take on this new mentality/personality (= new lifestyle) and make this grow within you and in so doing, reform your synapse construction being the retained mapping information that Yahweh stores to reload back into the brain of your re-constructed and now perfected DNA virgin body.

We understand now that this person is very different to the standard person who has not taken on this new personality.

But we have been told by JC that both groups (and all those in-between) have **all** been saved – so why did JC say to these special people in this last group, they will have **life**?

The crux of this point is that when JC says: “You **shall** have life”, he is making a promise!

The promise is that they ‘will have life’.

So what?

The point is that ‘a promise to life’ means that = **Life**, and thus, **not** death at some (any) point in The Future.

Thus it means “Life with **no** death at any point of time in The Future”.

= Everlasting life.

And because it is a promise of eternal life then:-

= Guaranteed Everlasting Life.

= Their names are written into one of the 144000 locations of “The scroll of (guaranteed) Life”.

Now we start to see a differentiation between the two statements JC made in his ministry.

1. Means that **all** humans are to be saved from the 1st Death (so that it now becomes “Asleep”).
2. Means **some** humans from (1) will have guaranteed **everlasting** life (and thus never see The 2nd Death).

Thus by default it means the remainder (= some 99.9+% of the population) of those in (1) being excluded from those in (2) do **not** have guaranteed life.

If they ‘do not have guaranteed life’ then that means at some time in The Future they can/could die.

And because The Bible tells us specifically many times that JC only “died the once” and thus can only pay as a redemption for our sins for the once, then that means those of group (1) who die in The Future can never be resurrected again.

The Bible is very clear about this, it is termed “The 2nd Death”, being a death of annihilation.

Interesting this understanding is further supported by The Bible when it speaks of those humans in group (2) being resurrected into a heavenly/celestial/spiritual body upon which “The 2nd Death has no power upon them” (Rev.2v11, 20v6).

Thus their spiritual bodies are not subject to corruption being death. The Bible also tells us that these ones are resurrected as “The Bride of Christ”, called “The Sons of God”.

This ‘2nd Death of annihilation’ is annihilation because Yahweh has deliberately kept no (= zero) records of our synapse mapping records after our resurrection – He destroyed the HD DVDs (equivalents) at our resurrection, He has no more need of them – because JC only **died the once** and it would be most unrighteous for Yahweh to resurrect a human again from DNA amplification again to reload the next personality upgrade into their body for a 2nd time.

For Yahweh has no basis upon which to be changing His Statutes.

Thus as Yahweh said: “If you sin, you shall die” Therefore you shall die at your 2nd death if you sin again in The Future, and because JC only **died the once**, and thus not to cover us after we have entered what I term ‘The 2nd part of our life’, being a resurrection into The Millennium (by using up JC’s first and only covering up of our sins being of the 1st part of our life = up to our “asleep” = up to our 1st Death).

Thus the reader is able to see that when Paul spoke of the future in terms of an earthly body and a heavenly/celestial body, then he was trying to tell us that our future could be either in an earthly (DNA) body or it could be in a heavenly/celestial (spiritual) body. The fleshly body is still subject to corruption (death, thus to be “The 2nd Death”), but the heavenly/celestial (spiritual) body is incapable of corruption (cannot die and thus can never be subject to ‘The 2nd Death’).

Thus we can be resurrected into The Millennium to learn righteousness in a fleshly body that is still subject to ‘The 2nd Death’, or (the ideal from Yahweh’s point of view – and ours) we could be resurrected a little earlier (3.5 years earlier) at the 1st 2nd Coming of JCg to collect his bride from the earth in a celestial/spiritual body. Thus being JCg’s bride then we (if elected by Yahweh as TCs) will have the same type of body that JCg has now because as The Bible tells us we have become one with JCg (= The Bridegroom) in a “special marriage” ready for The Millennium and ‘the children’ from this “special marriage” we are told by The Bible will be those resurrected ‘fleshly bodied humans’ (= the vast majority of us) who successfully take up a righteous personality during The Millennium, demonstrated by a lifestyle of commensurate works.

Thus the reader is now able to see that there is a distinct difference and application between JC’s two statements given during his ministry.

Now let me explain the half truth and half lie given by the very worldly Christian teaching designed to mislead and confuse, so that humans do not know what Yahweh’s Desire really is.

I think a definition of what the word “Believe” really means in Greek is required now.

It means “commitment, entrusting, have faith, to put into practice what you know.”

It does not mean “I believe because I know” or “I believe because I accept JC is my god” (see note at the end) and then do not wholly put into practice what you know – because that makes you a hypocrite – which is precisely what JC said of The Pharisees specifically as a warning for The Christian Nation to follow!

To explain “believe” with an example:

You can say: “I believe in gravity”, but unless you put into practice every day what you know by respecting “Gravity” and what it really means, then you will die an early death!

Now taking that last example we start to come very close to what JC means when he speaks when using the word “believe” the Greek word being “pistis” (Strong’sTM = 4102).

Particularly so when he speaks “of some humans not believing” and he was speaking directly about Judas Iscariot who had spent several years with him experiencing the miracles and the teaching alongside JC. And further, when going out in two by twos he would have participated in his own miracles – we are told no different in The Bible and as such, can assume this to be true.

So JC meant something ‘very much deeper’ when he spoke of “believing” rather than what we speak of today, because Judas would have had even more strength ‘in believing’ in JC than anyone of today **IF** (and only if) “believing” meant what worldly Christian leaders speak of “believing” today.

Thus we are now directed back to my original definition of what “believing” really means:

“Commitment, entrusting, have faith, to put into practice what you know.”

And what we know and understand is what we learn from JC. This completes the full virtuous circle.

The Bible tells us to put on new clothing and throw away the old clothing, being our personality that drives how we conduct our lifestyle.

Thus ‘true believing’ means:

“Imitate JC’s lifestyle in our own lifestyle.”

So how do we tie the two halves of this piece together?

1. What **Save** and **Life** means when JC used them in his statements.
2. The distortion/{half truth}/{half lie} of “Believe in JC to {be **saved**}/{have **life**} put out by worldly Christianity as its own message designed by Satan to confuse ‘the masses’.

We now know that JC **saved** everyone on this planet from their 1st death so that it now becomes just “asleep” – but you do not need to know or believe in JC to receive this gracious Undeserved Gift for which no works can pay – thus obviously **by default** it is **freely** available to **everyone**!

This logic immediately destroys the argument worldly Christians use to say:

“You must ‘believe’ in JC to be resurrected again to life.”

Again the confusion of the word ‘life’ and the ‘automatic’ assumption to get it forever!

For the sole reason The Bible tells us “it is a free gift for which no works can pay” and “is open to all of mankind”. Now worldly Christian institutions have lost one lure to draw the flock in to feed their finances (and personal prestigious position as leaders).

And:

Just like **all** the other worldly religions who use the same lure: “Belong to our religion to be saved!”

Quite clearly this one and thus common slogan must logically come from one source = The World for the world from Satan – and I explain precisely why – see “Satan’s Desire” in Glossary!

Because logically it cannot come from Yahweh because His only investment in The World is only through JC and True Christianity (which other worldly religions ignore) to deliver the 144000 members of JCg’s Bride for the next stage in Yahweh’s Plan. The Plan being The Millennium where resurrected fleshly humans become sifted and sorted during the 1000 years while they are taught righteousness = The Judgment period over their life being made up of two parts being the 1st and 2nd part!

Can the reader see the indisputable righteous logic behind all of this?

And further it is specifically what The Bible tells us and is never taught by worldly Christian Leaders for the sole reason they do not understand what The Bible tells them – being just “a mystery to them”!

However if they have read this then they have no excuse before Yahweh for not understanding – thus it becomes incumbent for them to start teaching this information to their congregations – else they stand accused!

Thus summarising the above points:

Point 1. Thus all worldly religions are **lying to us**! – Because it is only through JC’s action that all humans will be resurrected “irrespective of what they believe” only made righteously possible for Yahweh to operate only because of His son’s (JC’s) most wonderful action for his creation.

Point 2. We know that this resurrection for all those in a fleshly perfected DNA body is **not** guaranteed life, because these humans resurrected still have a worldly personality. The personality of these humans still needs to be reformed to have ‘everlasting life’.

Just retracing our steps so that we understand what is logically going on.

What the reader must understand is that the TCs who will be resurrected as “Sons of God” into spiritual bodies have already **demonstrated** their ‘belief’ to The World being what it really means because they “believed in JC by imitating JC’s lifestyle to the very best they were able” in the 1st part of their life (during The Gospel Age – as only judged by Yahweh) – that is why they are resurrected into bodies that cannot die. They have made ‘The Grade’ in Yahweh’s Eyes through The Special/Greater Judgement that He has carried out when, as we are told in The Bible:

“He (Yahweh) peers through the glassy sea” (always in prophecy “glass = clearly sees through”, and “sea = mankind”)

Being to elect those TCs out by their actions that imitate JC’s lifestyle in the 1st part of their lives.

That is why they have **guaranteed life** in spiritual bodies when they start the 2nd part of their lives because they have fulfilled their end of the agreement/covenant and they then receive the promise – not available/given to the prophets of old Israel. We are told by The Bible that these prophets looked but could not find – only because they did not have the perfect standard upon which they could emulate – being JC’s lifestyle. However we of The Christian Nation during The Gospel Age have no excuse – we now have The Golden Standard to assay ourselves upon, and further for Yahweh to assay us against on an individual basis.

But those humans who are resurrected back into a fleshly body have not demonstrated that quality yet (to The Golden Standard set by JC’s ministry and demonstration of Yahweh’s Acceptable Year) and thus must learn righteousness from the assayed/proven TCs (as faithful trusted stewards given responsibility over greater things being 5 or 10 cities – all quotations from The Bible) who now will teach these resurrected fleshly humans how to imitate JC in the 2nd part of their life.

The Bible tells us this will be a period of 1000 years which I term ‘The Millennium’, which The Bible also calls “The Lord’s (Yahweh’s) Acceptable Year” because ‘a year’ represents ‘The Growing Period’ to maturity of either a grain of wheat, or a seed of a worthless weed (see the parable of The Darnel seed).

The wheat represents something desirable, and a weed represents something undesirable.

“Wheat” represents humans who successfully have eternal life (either in heavenly/spiritual or fleshly bodies) and the “weeds” are those humans who will ultimately face ‘The 2nd Death’ of utter annihilation – it will be as though they had never existed. That is why they are burnt up by Yahweh’s power of extinction.

The 2nd death can occur at anytime during the 2nd part of a fleshly human’s life but during ‘The Millennium’ where righteousness will be taught to the whole of society, then this new society will be driven from a righteous stance where humans will gain and profit by being righteous towards their neighbour – naturally this will be mutual. It must be realised by the reader that detection rate for any ‘crimes’ against persons or society will not have a detection rate of 1% or so as it is during the 1st part of their life but rather 100% detection rate with an appropriate punishment to suit and thus cajole people into a righteous behaviour. The reader must also realise that because we shall be resurrected as all equal then those attempting to commit crimes in the 2nd part of their lives may be very different to those who we witness today during the 1st part of their lives (where some are forced to steal wholesome food – just to survive).

Thus the reader is now able to see where the half truth of the very worldly Christian teaching is correct, fleshly humans will be saved in the 2nd part of their lives from The 2nd Death only by believing in JC through the following understanding:

“Commitment, entrusting, have faith, to put into practice what you know.”

Which they now learn from a righteous society being cajoled/driven by the Kings/Priests (being the resurrected TCs now as “Sons of God” – having the full power of Yahweh which they are able to exercise to ensure that righteousness ensues).

Thus when the correct definition of “believing” is followed, then “Yes” humans will have salvation, either to:

1. Guaranteed everlasting Life, if imitating JC is practiced in the 1st part of their lives
- OR:
2. Everlasting life while you imitate JC during the 2nd part of your life, else face ‘The 2nd Death’ of utter annihilation.

It is this subtlety that is utterly lost in the worldly Christian teaching designed to fudge everything over to confuse the listener – but only because worldly Christian leaders do not know the distinction between the two themselves – quite simply they presently do not understand ‘1st century Christian’ teaching!

The problems the false message as presently taught by worldly Christianity gives us are:-

1. People think that knowing about JC will save them from the 1st death – No!
Because that is freely given to sinful humans – thus logically it must be to all humans.
2. It breeds contention because it makes Christianity like any other worldly religion, to mean ‘believe in what we say, to save yourself from the 1st death’ – No! for the same reason in (1).
3. It provides a barrier to obtain True Christians (TCs) being Yahweh’s true Desire for The World, because He needs 144000 of them in the next stage of His plan for mankind’s ultimate salvation. The previous text (and elsewhere on this website) explains how all this righteously operates.
4. It creates a lawless society where humans do not have “The Expectation” being of Yahweh’s Acceptable Year (and because no one has heard of it today, 2007 – then it proves my point) and thus they loose the focus of ‘the future goal’.
5. Because humans have no focus on ‘the future goal’ (because they have never heard of it) then they start to look to ‘please themselves’ rather than edifying their neighbour’s needs by bringing ‘the accurate knowledge’ of Yahweh to them. Thus fuelling crime to fund self-indulgent and very worldly activities – just what Satan desires to see!
6. People disregard True Christianity because it has been tarnished with the worldly distorted versions of Christianity that are illogical, have partial Truth, but also pandemic with the half truths/lies and hypocrisy which all humans are astute/wise enough to see through.

Thus the reader is now able to understand that because humans do not have the whole Truth but little bits haphazardly put together, then they become dispirited with the seen inconsistencies and also not knowing of Yahweh’s Acceptable Year, (which incidentally was JC’s mission specifically to preach of it), having no future Expectation, all this just fulfils Satan’s plan to disrupt/resist/oppose Yahweh’s Desire for “The Absolute Truth” (of ultimate salvation) to become known to The World.

Thus Satan (being ‘the pretender’ to the throne) is specifically sowing disinformation through all the worldly religions of The World (including ‘very unscientific’ mAcro-evolution myth, based upon the scientific truth of mIcro-evolution) just to get people thinking about anything other than what Yahweh Desires humans to think about!

“The Absolute Truth” is “The Expectation” generated from The Knowledge of ‘Yahweh’s Acceptable Year’ which is ‘The Future Millennium’, where JCg **will** rule with power. Firstly as we are told by The Bible: “JCg will be restraining Satan for a 1000 years” so that “JCg is able to exercise full power to teach righteousness with his Bride” being “the 144000 of New Spiritual Israel” being “the resurrected TCs as kings and priests”. Sadly worldly Christianity is so far adrift from reality, because its leaders preach that The Gospel Age is The Acceptable Year in operation now!

They are so far adrift from reality and blind to “The Truth” because The Bible tells us in Hebrews that Satan will rule as custodian god for 6000 years which take us up to about 2000AD plus a few decades, and that I see no change in the pain and suffering in the world as being different between the time periods before and after JC’s ministry period. Except it is accurately recorded that there has been more deaths/destruction from the abuse of power (which technical knowledge gives) used within the wars of the 20th century than all the previous 1900 years put together!

So:-

How can this mayhem be acceptable to Yahweh? – Or is He and JCg impotent to mankind?

Does this make mankind more powerful than Yahweh?

Thus if mankind is apparently more powerful than Yahweh then it makes ‘this period’ ‘Mankind’s Acceptable Year’!

We are told Yahweh’s Acceptable Year is 1000 years long – we have already had 2000 years from JC’s ministry – perhaps Yahweh has forgotten?

Clearly not, basically worldly Christian teaching makes this appear so - by their worldly preaching (to the glory of Satan who is presently ruling – soon to be deposed).

So who are they representing?

They must change what they preach, to what this website teaches – now they know “The Absolute Truth” as specifically given on this website!

The Bible also tells us that Satan is presently ruling as “The Spirit of the Air” – meaning his influence is everywhere around us – effecting / polluting everything we do.

Thus, all this false teaching by worldly Christianity preaches lawlessness to the glory of Satan, because it resists/opposes Yahweh’s Desire to know precisely what JC came to preach and show us by demonstration in his locality where he operated in Israel. Thus Yahweh’s nearness of “His Acceptable Year” was **by application** (in the locality – for all to witness) and **not** in the time domain.

So after been given “The Absolute Truth” the reader must ask him/herself this question:

“Who is fulfilling Yahweh’s Desire, and who is fulfilling Satan’s desire?”

Note: I use small “g” because JCg is the “Son of Yahweh”, it is Yahweh who as being The Almighty God has the “G” because JC always referred everything back to his Father, and likewise I follow the same practice. The Bible, as I meticulously explain elsewhere, uses the Greek Words “Ho Theos” to mean: “the specific god” but this must be taken as a “variable pointer” and not an “absolute pointer” depending upon subject context.

If the subject context is us humans then “the specific god” points to JCg

If the subject context is JC (JCg) then “the specific God” points to Yahweh.

This **factual understanding** has been missed by all worldly Greek scholars/theologians for that last 1800 years, but it is a concept used by software writers for the last 30 years ‘reinventing the wheel’.

Please see “Ho theos” in Glossary and Concordance of Topics.

Now coming back to the quotation located within Acts.16v31 taking out of context by worldly Christian Leaders used merely to bolster the numbers within their flocks for self-indulgent reasons for they do not place that quote in context of The Holistic/Righteous Plan of Yahweh as given by The Bible. So let me do that now.

Other particularly pertinent verses applicable to this discussion would be: Luke.8v12, John.6v64.

All other verses in The Bible on this subject just lend support to this whole document when “believe” is understood by explaining these two other verses within context.

First we had better understand what “believe” means!

The word used in The New Testament is StrongsTM = 4100 = “pisteuo” = “to credit, entrust, commit, believe” and is derived from 4102 (“Faith” see Glossary) as I have explained earlier having much more weight than commonly understood because worldly Christian leaders have devalued these words just to be more inclusive for self-indulgent reasons of ‘exciting’ their audience to attend their meetings!

We understand that “to credit” means “we owe and become indebted” to become beholden to the person we are indebted towards. We thus are obliged to ‘work-off this debt’ for righteousness/equitability to exist in Yahweh’s

Universe. I hasten to add ‘there is nothing we can do to fully work off this debt’ – because it is too great and we are too inferior – but that does **not** mean that we ignore this part, but rather there is this onus for us to do the very best we are able to repay what we are able within our capabilities, even though it will be over a lifetime of an eternity for those successful humans.

There is much in that apparent paradox for the reader to reason upon especially within the context of this essay! We understand that “entrust” means “commission in fidelity” to give our life in a fashion to imitate The One “**upon**” (being The Greek word and not “**in**” as within the misquoted phrase of Acts.16v31) whom we are indebted that we might find good favour over this debt (from The Curse of Satan). We are told this debt cannot be repaid because it is so great, but we are told ‘where the one debtor forgiven in much is (or **should be**) more grateful than those debtors forgiven in small things’ – where the gratitude should be expressed through works. These are very important terms for the reader to fully comprehend.

We understand that “commit” means “give a pledge/consign” to give our life being the only thing comparable to what Jesus did for us, back to Jesus by precisely imitating Jesus in offering our life by us dying for The World inasmuch we spend all our time (outside our **daily** needs for the fleshly body to survive and family commitments to teach them how to behave) in accurately teaching The World in a fashion to imitate The One who himself gave his life to The World to teach The Acceptable Year of The Lord (which we can do –and thus must) and provide The Ransom Sacrifice (that we cannot repay – but only, that we dedicate our life to imitate his preaching work displaying the fruits of the Spirit – Personality/Desire). If we do this to the very best we are able then Yahweh will consider that we have imitated Jesus to the very best we are able and resurrect us like him – to have **guaranteed** life as this document explains. Else we will be resurrected to learn how we might imitate Jesus in a more conducive society to be righteous – but having missed Sonship to Yahweh, though still having the possibility to become a son (/daughter) of Jesus and his Bride (of the special marriage) – precisely as this document also explains.

Now we understand what “Believe” really means and applied within context – then we understand it is **not** what it is glibly taught by worldly Christian Leaders to increase the size of their following – because if they taught what it really means then most of ‘the flock’ would desert them and they would receive no income nor glorification by their ‘milking the congregation’ – giving what it wants to hear for minimal commitment! I suggest that the reader reads the whole of John.Chapter6 for it gives great insight into The Bible, where we are told the crowd deserted Jesus when he gave them a real sermon! The disciples said ‘Hard are these works – who can do them?’ and we also read about the nominated verse speaking of Judas who knew so much more of Jesus ‘to believe in Jesus and be saved’ than anyone today – but yet he did **not** believe. Thus it is not the “believe” spoken of today in worldly Christian gatherings – but rather “the belief” that I explained under the additional words “to credit, entrust, commit” that Jesus really meant!

This also now ties in with Luke.8v12. For Satan does not desire any human to fully imitate Jesus by **truly** “Believing in Jesus to be saved by having **guaranteed** life” as a son of God for it hastens his demise!

Please see “Yahweh’s Desire” and “Satan’s Desire” in Glossary to understand precisely what is occurring now and why paradoxically, worldly Christian leaders are actually delaying the onset of The Millennium being the very thing they supposedly espouse – being The Kingdom of ‘god’!

The reader can see how I have turned worldly reasoning up on its head in this piece – only because worldly Christian leaders are so utterly confused on almost every aspect of The Bible – because their god has confused them with worldly wisdom!

Hopefully this website can untangle the mysteries that worldly Christian leaders seem to enjoy wallowing within, and by untangling these mysteries to The World at large I can give The Expectation of a most wondrous future as a beautiful vista laying out before all of us – but please start imitating Jesus’ lifestyle now to reform your synapse construction (being your “Heavenly Treasure” see Glossary) – for your future will be so much easier – and you shall find favour in Yahweh’s Eyes as He told us (Luke.9v35):-

“This is My beloved Son – Listen to (= *Imitate*) him!”
