

Why did Jesus start another 'Religion'?

Because as Jesus told us: "New wine could not be put into old wineskins."

(Meaning: 'The Knowledge' termed "wine" correctly explained, thus new; could not be put into 'the reasoning centres', = the brain termed the "wineskin", of those humans who reasoned upon the old knowledge).

Well that is it – I can now finish the essay!

Or can I?

Why should we not be in the position to argue that:

Subsequent religions and offshoots are equally valid - according to this answer of Jesus?

However practicing exegesis on these worldly religions delivers 'these belief systems' to be without substance, just a façade giving an appearance of something substantial inside but could be likened to a balloon that would go 'pop' if you pricked it!

The point being made would be this:

Why should 'An Outside Entity' legitimise 'True Christianity' as given by Jesus as being "The Only Truth" for Mankind (other than the content demonstrating this) and not any subsequent religion or offshoot making its debut during the last 2000 years?

I wish to show by logical reasoning why "The Outside Entity" being "The Almighty God" would only have 'True Christianity' = being 1st Century Christianity (and not the present masquerade of worldly Christianity) as the only Fidelity that has any legitimacy operating on this planet and thus all other beliefs are from 'a deviant source' trying to suppress "The Absolute Truth" of "True Christianity".

I shall also explain why 'The Deviant Source' uses other worldly based beliefs to suppress "The Absolute Truth" as given to us through Christ Jesus.

The 'main reason' is never preached by those of worldly Christianity because the leaders do not understand The Bible that they purport to represent – else logically, they would preach it! And thus they are like 'the old wineskins' themselves steeped in some 1800 years of doctrinal history, that makes them no different to the time of The Pharisees – of whom Jesus was using as an example during his 1st advent, as a mirror to his 2nd advent which is soon to occur.

What do I mean?

I ask the reader this question:

When was the last time you heard "The Millennium" of 1000 years preached by a worldly Christian Leader in their sermons?

I suspect at the time of this original writing in May 2007 the answer is virtually no one!

I give this date because I believe in several years time, everyone will be hearing of it!

That is the whole point of this website to avidly broadcast/herald/proclaim/publicise:-

"The Good News" to The World of humans -

being the very thing Jesus preached/taught/demonstrated "the nearness of" (in application) during his 1st Advent (of his physical presence) some 2000 years ago.

This "Good News" shall soon become a reality, – it is of "The Millennium" period of 1000 years that The Bible screams out to The World and that this website so gladly proclaims!

What does all this mean?

Irrespective of what any worldly 'authority' states on this subject in error, you will now be given my understanding of what is occurring during the last 6000 years and I challenge these acclaimed worldly authorities steeped in 'worldly wisdom' to provide scientific and/or historical evidence (not to hypothesise – because they were not there) to refute what I state here.

A very brief overview because I explain it much more deeply giving all The Evidence elsewhere on this website www.FutureLife.Org.

1. Standard reproductive mechanism produces new generations of humans originating from a unique genetic pair some 6000 years ago. Earlier fossils were humanoid but had not the cognitive powers of humans – specifically, the capacity to recognise and communicate with extraterrestrial Entities that we would term ‘God(s)’, for when was the last time an anthropologist saw an animal build an altar to another entity? Thus we have an innate cognitive desire/ability to interact with extraterrestrial ‘Beings’. This is just one aspect that scientists say: “separate humans from animals”. Earlier humanoids had not this ability – essentially they were ‘human prototypes’ proving a versatile fleshly structure/frame, but only having animal cognitive abilities. The first human pair also had the ability to reason/muse upon abstract qualities, have a wide consumption of aesthetic appeals (music, art, etc), to have empathy within and without other species, but most importantly to have the capability to make moral decisions to either edify or hurt one’s neighbour.

2. Other properties that the original pair had were ‘self-repair mechanisms’ inbuilt within their DNA fleshly frame whose design had been ‘proven earlier’ within other ‘prototype’ animals – for instance the ability to regenerate lost limbs like crabs, lizards etc. Further commensurate with the cognitive abilities, the human fleshly frame was given the ability to repair the telomeres at the end of DNA sequences (chromosomes), combat NOx damage, also producing anti-oxidants to control ‘free radicals’ and further, the inbuilt mechanism to control the turning on and off correctly any cancerous cell growth to frustrate future cancer break-out. This capability was serviced by what The Bible termed “The Tree of Life” which provided enzyme precursor based material to sustain the ‘system support’ DNA. However when these two genetic ‘master-pieces’ (Adam and Eve being ‘The Culmination’ of Christ Jesus’ design) disobeyed Yahweh’s Universal Edict (applicable to all cognitive reasoning entities within The Universe) then “The Tree of Life” was removed from these two individuals, and thus the ‘system support’ DNA started to break down in discrete, quantised jumps as accurately described in Genesis to form what we now term “Junk DNA” being the hybridised residual DNA that now forms ‘no purpose’. This is why humans started to die off in the discrete jumps as recorded in The Bible as specific sections of DNA ‘system support structure’ broke down.

This was reinforced by The Flood that ‘bottle necked’ the DNA into the surviving eight people and thus delivered in their offspring through the final DNA quantised decay to give the discrete steps down, to finally, 70 years that we now witness, which naturally can be shortened or lengthened depending upon the care taken by the individual involved. Clearly mutated faults can further shorten this lifespan.

This may cause consternation in ‘Evolution circles’ because it is the exact opposite to what the proponents (who ‘believe’ in nothing else) ‘preach as being their religious ‘truth’’, and thus what I have proposed is eminently more logical because of what we witness in our life – being degeneration around all of us! I could expand this section so much but this is not the forum upon which to unveil evidence of DNA degeneration based upon the mass of scientific evidence – filtered by their ‘rose coloured glasses’ – for their ‘doctrinal reasons’!

3. However as with all animals within a corruptible fleshly frame, they die, likewise all humans now, will also equally die. The ‘soul’ is no more than a ‘living entity’ - essentially a fleshly frame having brain synapse operation. When the fleshly body ceases to function, then so does the synapse operation and thus become termed ‘clinically dead’ = absolutely dead.

Thus I term an animal or human as being like a computer made up of hardware and software.

The fleshly frame is the hardware and the synapse operation (forming the connections) is the software. Separate the two parts and the computer is dead. The hardware is lifeless, and the software on a disk (being merely a record of the synapse mapping) has no capability to operate – it too is lifeless. We humans operate identically to this. There is no ‘ethereal thing’ that wanders around space ‘looking for a home’ after the human is dead as stated by all the false worldly religions. When you are dead you remain dead for an eternity in a non-existent state that is impossible for you to even realise that you are dead!

This is a mere outline and I fully expand all this reasoning elsewhere. Please see my Glossary under the words “Life”, “Soul”, “Heavenly Treasure” where I develop and explain this concept more rigorously.

4. However – that is how it would have stayed until humans as a species destroyed themselves off the face of this planet by exercising unrestrained selfishness of varying degrees in the form of “self-indulgence” throughout the strata of society. The human species would become extinct and ‘that is that’ = The End!

But we were/are the final part of a total creation by Christ Jesus over the period of time that we see witnessed in geological time expressed in ‘God’s time’ as ‘units of days’ (being eons of our time – I fully explain this in my Glossary under “Day”). Christ Jesus used his Father’s (Yahweh) basic building blocks being “The Basic Laws of Nature” to create DNA and thus created all forms of life that we witness around us - ending in The Culmination

of his Creation process being what we would term 'The Human Species' having all those superlative qualities mentioned earlier!

So think how distressing that it would have been for Jesus to see The Culmination of his Creation that was always subject to his Father's righteous Decree become, by free choice become a willing victim to it:

"In the Day you sin you will (begin to) die (everlastingly)."

As I copiously explain elsewhere, Jesus so loved his ultimate creation that he volunteered to righteously/equitably balance/cover each individual human's 'life of sin' against his Father's Decree. This enabled a "**Reset**" condition to occur in our life. Thus when we die, we then have an automatic entitlement being a single 'credit life' = a 2nd attempt at getting our whole life correct before Yahweh's Decree.

Thus righteousness is displayed because it shall become a **personal choice** rather than **a decision made on our behalf** as it was originally done for us by Adam and Eve in the 1st instance and then rippled through their progeny of the faulty DNA frame. So this DNA repair can come later, upon our resurrection = during our fleshly reset condition!

So instead of us now dying and remaining unconsciously dead for an eternity = annihilation, then The Bible terms this 1st death as being "Asleep" because of this one/single 'credit life' made possible by our creator (Jesus) before his Father's (Yahweh) Decree that is **universal** throughout The Universe and will never be repealed. This **reset** condition (being this 'credit life' **exercised**) can be used ('cashed in') early (by some humans as I meticulously explain elsewhere) or it will be used automatically by default the instant upon resurrection into what will become termed 'The 2nd part of our life'.

The 2nd part of our life will start upon our resurrection into "The Millennium" which is never preached by worldly Christian leaders because they do not understand it, and most of them do not even believe in The Millennium! I invite them to refute this statement – giving detailed reasoning to support their errant understanding - naturally quoting Biblical text in context!

I explain precisely why they are, and behave like this elsewhere on this website!

5. We now understand that it was Jesus who made The Millennium period possible. The Millennium period is called by The Bible as "Yahweh's Acceptable Year" because 'The Year' in The Bible signifies 'the complete growing period' of a human from birth to harvest. As we are told by The Bible it can be to 'a harvest into Yahweh's Granary', or gathered and 'burnt in a pile' = eternal destruction = annihilation. This would have been our future at our 1st death if Jesus had not **volunteered** his life as "The Ransom Sacrifice", being "The Underserved Gift" to give us this **reset** opportunity into The Millennium to then **complete** our growing period as the Parable of the Darnel Seed given in The Bible clearly tells us.

Now given this brief overview, the reader can now understand why Jesus had to make his 1st advent into this present world.

But it does not stop there. As I stated earlier we will all be resurrected again, but we will unfortunately, be like we are! Our personality will be **identical** (= a clone) to the personality we had when we died and, many people's personality is presently - very unpleasant!

So what are we being reset into? A world as we are living in today?

If that is the future then I do not really desire to be resurrected!

However this is not to be The Future of all the individuals who have lived!

The Bible tells us that Satan being the present 'god of this world' that most people 'pray to' – being 'the god of this worldly mess of operations' demonstrated by their works of self-indulgence, then this god Satan will be constrained for 1000 years, and thus will have no power of dominion over us.

He shall be constrained because The Bible tells us several times that we all, including Jesus, must be patient until a special time arrives – then as we are told, Jesus will be given full power (authority) by his Father Yahweh, to put his enemies at his feet.

So what and when is this special time that we are all waiting for?

Being The Time when Yahweh states to His son:

"Enough is enough. My Son Jesus, with My blessing and full power, you now move in and sort this present worldly mess out"!

This time commences at what we know as the 7th (being the Hebrew for **completeness**) block of 1000 years which the Bible also calls "The Restoration", after the previous 6 blocks of 1000 years under Satan's misrule/inept management – which Paul clearly explains to us in Hebrews.

Also which is why The Bible tells us "the 7th day of creation is not complete" because it will be completed at The Culmination of the 7th Block of 1000 years when the remaining humans are perfected - which afterwards becomes The Jubilee the 50th year (after 7x7 blocks of time = utter completeness and perfection). Basically it mimics the 6 days of working under Satan's system of pain/suffering and the 7th being a (The) 'Day of Rest'

from it, where we are told (by Peter) twice in the same verse a “Day of the Lord is 1000 years” (as we are told – so that we should not be ignorant of this fact see 2Pet.3v8).

This 7th block of 1000 years is “The Millennium”.

Thus it is during this period of The Millennium where all are resurrected into a **reset** fleshly body (performed for us by Yahweh – righteously acting because of what Jesus performed for all of us), then it becomes **our personal responsibility** to reform our synapse construction. Jesus in his creation through DNA gave us certain predefined pathways (mapping) as a starting position, but Jesus also has given us the ability to strengthen and weaken these synapse connections to reform our thinking (The Bible calls this “Readjusting”) during our education – if we personally so desire. It is during this future period, when knowing of the past, being our retained memories (being our 1st life = now becomes the 1st part of our life after Jesus’ Undeserved Gift so graciously given), and learning from our mistakes that gives us the motivation and thus working with this ‘built in’ ability to personally create a righteously operating synapse construction/mapping within ourselves to create our new personality in The Millennium.

So we will become cajoled by Jesus and his assistants of Kings/Priests (see later) into adjusting ourselves to become righteous. Thus we learn to become righteous in our thinking, operating in our perfected DNA resurrected fleshly body (given/bestowed/granted to us by Yahweh) that is physically capable for lasting forever. This is only one half part of ‘eternal life’.

However ‘Eternal Life’ can only ‘be eternal’ if we **constantly imitate** Jesus in our actions else we sin and Jesus only “**Died the once** for us” as The Bible distinctly tells us several times for our warning, and thus we have no possibility of any return from our/The 2nd Death which then becomes ‘a death of annihilation’.

Thus the reader has been able to see that we have had our fleshly bodies **reset** for us by external Entities and now it becomes our personal responsibility to learn how to **reset** our personality to become Christ-like over this learning period of time of 1000 years – to produce something that Yahweh Desires to operate within His Universe.

So when is this wonderful time called “The Millennium” to occur where we become resurrected into perfected DNA bodies and have an opportunity to readjust our thinking by putting on a new personality – for eternal life?

The Bible tells us there are three things that shall come together before Yahweh will instruct Jesus to move into this worldly system and end what is presently termed “The Gospel Age” to bring in his (Jesus’) Millennia Rule of 1000 years (termed “**Crisis**” = judgement for some people where they must make the correct decisions).

1. When the earth has reached its full capacity to accept all humans who have existed during the last 6000 years, less those iniquitous humans who will ultimately be removed at The 2nd Death. This number will be the total quantity entering into Yahweh’s Granary at the end of The Millennium period to live forever in the most wonderful paradise/society/(Park = garden) upon this earth.
2. When the correct number of “Faithful/Trusted Stewards” has reached the ‘threshold’ number of 144000 elected/chosen by Yahweh (as The Bible specifically tells us) from this period of the last 2000 years – termed “The Gospel Age”.
3. When the earth has sunk into such a terrible situation that Yahweh must step in through Christ Jesus “else no flesh will be saved”, and “the times will be so bad as have never been before, nor shall be” to quote The Bible.

These three things will **occur together** – as being “The Signal” for Yahweh to operate His full Power through the compliant Christ Jesus.

We can see (1) naturally occurring, (3) is steadily occurring as we witness the earth’s resources being used up, the power brokers are those having control over these. Finite hydro-carbon energy sources, food shortages now, and the fast approaching clean water shortages on a global scale, more violent weather patterns (caused by mans’ selfishness for self-indulgence that burning millions of years of accumulated resources up within a century), rising sea waters so forcing millions upon millions of humans to move up from their present coastal areas due to flooding, economic upheaval that this will cause, pestilence and plague increasing due to resistance – just to name a few. All these things will cause enormous social conflict like we have never seen before – just as The Bible so clearly tells us, as the last part of the world’s various resources are fought over to retain the lifestyle enjoyed by those with the power to exercise it (to maintain their self-indulgence over their neighbour)!

So what does (2) mean?

“Faithful/Trusted Stewards” I explain in very great detail in many other places on this website giving all the support scriptures from The Bible to fully substantiate exactly what this means.

These ones are chosen/elected by Yahweh as having imitated ‘The Gold Standard’.

The Gold Standard was set by His son Christ Jesus during his 1st Advent, being his ministry some 2000 years ago and those humans who imitate Jesus’ lifestyle to the very best of their ability will merit “The Prize” just as The Apostle Paul said (to Timothy) about himself receiving upon his resurrection (2Tim.4v6-8). These special humans are chosen by Yahweh during The Gospel Age, and thus **elected from out** of The Christian Nation, that

as a whole is itself worldly, just like The Old Israelite Nation was prior to Jesus' 1st Advent. **Only Yahweh** (as we are told in several places) is able to choose those humans at the end of the 1st part of their life (1st death = "Asleep") who are deemed worthy/righteous to become a "Son of God" and thus become "The Bride of Christ" at the 1st 2nd C (see Glossary) that occurs at the beginning of The Millennium – just 3.5 years prior (see elsewhere for justification) to The General Resurrection of the rest of The World (that may be staggered over 100 year periods – see Isaiah's prophecy in chapter 65 of The Millennium period).

The World shall be taught righteousness during The Millennium, and those who are successful, by being "harvested as grain for Yahweh's Granary", are called by Paul "The Children of The Special Marriage" (of Christ Jesus and his Bride of 144000). Being fully Born (Again) as children provided they successfully inculcated righteousness (by the Holy Spirit growing within them) at the end of The Millennium – else metaphorically they are 'born dead' (having no Holy Spirit of life) being The 2nd Death = annihilation.

So what do we understand from the a forgoing section?

We understand that Jesus not only provided The Underserved Gift, but further he set "The Gold Standard" by which Yahweh was righteously (before all entities in The Universe) able to judge those successful 144000 humans upon to become His Personal "Sons of God".

These 'Sons of God' will rule as Kings/Priests alongside Jesus to teach righteousness to all The World of resurrected humans during The Millennium period of 1000 years.

Being like Jesus – they will be "god's" in their own right (being 'The Revelation' to 'The Mystery' of The Bible – being "How can a Creation of Jesus become like him?"). These 144000 representing The New Spiritual Israel (now 100% loving/loved by Yahweh as the old prophets tell us) shall not be resurrected into fleshly bodies as we all will be, but rather they shall be resurrected into spiritual/heavenly/celestial bodies that are not corruptible, thus not subject to The 2nd Death – exactly as The Bible clearly tells us (Rev.2v11, 20v6). Being like Jesus these 144000 – having proved themselves as faithful/trustworthy stewards by taking the humble position in the 1st part of their life, copying Paul as he copied Jesus, being constantly persecuted (an example perhaps would be William Tyndale) only because they wanted to deliver, and through works did deliver "The Truth" to The World. These 144000 will be entrusted by Yahweh to exercise His full power of The Holy Spirit to ensure that Lawlessness will never break out again while righteousness is being taught during that period of 1000 years – being The Millennium.

Just as Jesus told us, that he could call upon legions of Angels to protect him, likewise these 144000 would be in the same position. Just as Jesus was able to 'read the mind' of his opponents through the use of The Holy Spirit, likewise these 144000 would be in the same position to do this over The Flock of The World of resurrected humans that they would be administrating. They would be able to see though any lies being used as excuses by those who tried to rebel against 'The Righteousness' being taught to The World. They shall enforce Yahweh's Law onto The World – but this will not be troublesome or arduous to those people who want/desire a just/righteous/equitable society – most people will welcome it. The only humans resurrected who will hate the operations of this new society are those humans who during the 1st part of their life enjoyed the benefits of exercising selfishness on a grand scale towards those weaker than themselves (and climbed there to obtain it). These selfish, haughty ones shall be subdued or face The 2nd Death of annihilation if they refuse to reform their personality to support the now growing righteous society. This is just as The Bible teaches us where those who are high shall be brought low to become The Least, and those who were humble and took lowly positions shall be brought high in The Millennium. Speaks volumes about The Religious Authorities at the time of William Tyndale being who was high and who was least! And those 'players' at that time were no different in the day of Jesus, just as they are no different today!

That as outlined above is the very basic plan - being Yahweh's Plan to righteously extract all of us out of the appalling situation that Adam and Eve in their ignorance (of the consequences in the last 6000 years) chose for us. Yahweh having all righteous power to ensure that after what His son Jesus righteously performed, Yahweh shall exercise His power in a righteous manner to provide salvation for any human who ultimately desires to imitate Jesus' lifestyle where the edification of the neighbour is put before 'the self' (now not ignorant of the 6000 year consequences of rebellion against Yahweh's Word).

This **is** The Future of **all** humans (irrespective of what anyone states on this planet) – The Question is:

Do you 'believe' it enough to carry out the required transformation in your lifestyle so that you may become part of the positive aspect of The Future?

This is just the merest of outline to give you the skeleton frame for you to now 'flesh-out' by gathering the information from The Bible so that you become confident and knowledgeable in "The Expectation" of "The Inheritance" and thus gain the wisdom to enable your preparation for it.

Best to start now – because it will go much easier for you later!

For those who dismiss this Future scenario because they believe it to be a ‘supposition’, having no proof to underpin it.

Then I first ask – Disprove it!

Have you any evidence to prove me wrong?

Actually I will let you into a secret – if perhaps I was starting off from ‘square one’ like yourself - and not having knowledge of ‘the support structure’ that cements this all understanding together to form the most solid foundation – then I too would be sceptical.

You must understand that Satan being the present custodian god of this world desires so many false religions to exist - just so the ‘atheist mentality’ can be logically created! The atheist argues like this because logically everything the atheist sees supports what they presently believe – being the positive feedback. But by thinking like this, then they have fallen into the very trap they believe they are safe from!

The trap presented to all humans by Satan – is to encourage them ‘not to worship’ (= not to give due credence/time/understanding/works) to Yahweh, and Satan does not care how it is done – provided they ignore Yahweh’s Desire of them!

Satan allows humans to wander – seeking their own ideas, being ‘religions’ in their own right – being worldly religions because these religions come from The World for The World, that is presently controlled by Satan.

Please see Glossary on “Works”, “Idols”, “Worship”, etc.

So clearly there are faults within all these worldly religions, and the manner in which people behave who purport to represent these worldly religions, clearly have not had the personality change demanded of by Yahweh for ultimate salvation – and this is precisely what an atheist witnesses to reinforce their understanding through this positive feedback mechanism.

But they too have been duped into not searching for “The Absolute Truth” – because they do not think there is any truth in searching for Yahweh – thus without realising it, by taking this ‘enlightened’ course of action, have actually become ensnared by Satan – they have become duped into fulfilling Satan’s desire of them!

What I am encouraging all humans to do is just search The Bible, perhaps using this website

www.FutureLife.Org as a ‘short-cut’ to “The Absolute Truth” to minimise your time in discovering how all the specific prophecies, allegories, archetypical events/places/humans/times are beyond the conception of mankind to create and thus shows us that there is “The Intelligence” operating behind the scenes with “The Power” to ensure these things are occurring at the correct pace, just as they are. All worldly religions do not have these things to support what they state – thus they are based upon ‘blind faith’, and I gladly welcome those advocates of any of these worldly religions to contact me to give a logical explanation how their religion ‘hangs together’. Then I will dissect and analyse the response to publicly expose the ‘fault lines’ that flaw the religions to justify their worldly nature and origins.

Please use sections on this website to help you – so that you know beforehand from which of the angles that I will be dissecting and analysing your response.

So it is this understanding that gives me the confidence to accept what I have given to you here is the accurate outline of Yahweh’s Plan, so that you too may have an opportunity to make that personal change which shall be required of you in the future – and That Day is ever drawing closer.

So start now! – Because it will be so much easier later when you have no more opportunities to ‘get it wrong’ in The Millennium – from which there is no return from annihilation!

So now you know the basic plan, are you able to answer the question yourself?

1. Jesus provided The ministry of Yahweh’s Acceptable Year,

Thus all worldly religions logically have absolutely no relevance to ultimate salvation, except - if you personally, and ultimately ignore Jesus (during The Millennium) then you shall face annihilation.
