

What does God really want from us?

This document is primarily aimed towards people who already believe in “God” and thus has not been written for atheists (please see my other documents directed to the appropriate readers). However, I cordially invite atheists and agnostics to read this dissertation because it presents a worthy “Righteous Argument” that deserves consideration.

Definitions:

1. “**God**” = “**The Almighty God**” of The Universe = has “Supreme Authority, Capability and Omnipotence” over all “existence” and “matter” within The Universe. Without “The Object Reality” of this Entity “God”, we would not exist. A listing of Names (certainly not exhaustive) within certain religions call this “Entity”:

Notwithstanding the above, I understand “God's Name” to be “**Yahweh**” (as derived from The Tanakh) which means: “I make become who/what I choose to become”, or simplified: “I chose (what/who) to become”, and elect to use this “Title” in the remainder of this discussion.

2. “**want**” = “what Yahweh ultimately desires”

3. “**us**” = “all humans, now and ideally into The Eternity”

In answer to the question in The Title of: “What does God want from us?”

“**God wants a perfect society!**”

Being a “perfect society” that exists into “The Eternity”.

4. “**perfect society**” = “whose members all mutually edify their neighbours (which may be to the giver's own hurt)” “God” has **NO need for anything else from us** - except for us to personally achieve this Goal in The Most Righteous Manner. The very “Best Form of Worship” from us to “God” - is for us to personally achieve this goal of yielding and then maintaining a “Perfect Society”!

Think very carefully upon that statement (in the context of Isa.1v11-21, Amos.5v20-25), noting it is the opposite to what human leaders of politics, commerce and religion prefer (all of whom are operating according to worldly methodology, which is one reason as to why they take the position of being “**Leaders**”)!

So ... that answers: “**The Question**”, and I may as well end my writing here!
Or should I?

What we are about to read over the next pages - **applies to each and every one of us!**
Please bear this in mind as each paragraph is read!

Discussion:

The problem we face is that “Society is very far away from being perfect” by any measurement, in absolutely **ANY** circumstance or situation assessed, because a flaw can be found somewhere (even if 'that somewhere' means “an ideal state is not permanent”).

So: “How do we get from **here** to **there**?”

It must be recognised:

If we are not there, and have demonstrably not been there for the last some 6000 years (as documented),
Then “our character” (as a universal member of “Mankind”) is **not** the one/same as “Yahweh's Character”
(else obviously we would be in that perfect society now, - and yet we are not)!

“The Crux” of what is occurring today is that:

ALL people (without **ANY** exception on this planet) **ONLY** know of what “**Our Local Environment teaches us**” (being our personal intercourse with The World at any applicable level), we know of nothing else, unless we go **OUTSIDE** our “Normal Environment”

Moreover, what is worse:

We think, “we are correct” – even when we know of nothing outside our “Normal Environment”!

How bizarre is that!

Furthermore, “The Something” outside our “Normal Environment” may just be “Absolutely Correct”.

Which in this specific instance (being “The Reason” of this dissertation) is to yield “**a perfect society**”.

We may deduce people, who argue against the contents of this dissertation, may not desire a means to yield a perfect society, because they prefer the present arrangement (yet look around us now)!

Our present “Environment” is a form of “Surreptitious Propaganda” - to be accepted as “**The Normal**”!

People prefer “The Normal” - because it becomes “Uncomfortable” to leave what we know from birth!

“The Unknown” harbours “Uncertainty” – and humans can be naturally fearful of “The Unknown”, so they stay with what is familiar (and this provides reassurance within what we habitually practice).

However, if we are trying to gain “The Absolute Knowledge” (= “The Correct Knowledge”), then it is essential for us to:

“Get **outside** our Normal Environment” (because based upon “The Probability” equalling “1” [= absolute certainty] then what we know will **not** have “the absolutely correct knowledge”, but something much inferior)!
Because it is only when we have (1) “Yahweh's Absolute Knowledge” and (2) “a spirit/personality/desire/traits to behave in the one/same manner as Yahweh” shall we then personally discover how “The Perfect Society” can be achieved - because it is certainly not occurring now anywhere!

From which we recognise people must **not** have “Yahweh's Absolute Knowledge” (to yield a perfect society), else we would be of “One/Same Mind” to make a perfect society exist everywhere!

A general warning which may be a useful guide for the next step, because we surely have no desire to: 'Jump from out of the frying pan into the fire' by following a worse instruction - definitely sourced from Mankind (ultimately Satan)!

Therefore based upon what we generally observe within The World, then we have a useful tool to guide us:

“People who self-indulge” ultimately hurt (1) themselves and/or (2) other people (alongside).

What do we learn from this prevalent observation?

Perhaps the first thing we must do is to actually look outside “The Normal Practice” to achieve “The Perfect Society.”

Where:- “Outside The Normal Practice” would suggest:

Do “The **Opposite** to The Normal Practice” which is “**NOT** to self-Indulge”!

Therefore, we should ask of ourselves:

What does this mean?

Importantly: “To get off the 1st Square” enabling us to move forwards (so we may ultimately fulfil Yahweh's Desire) would be the question:

Do we want to: “Get off the 1st Square”?

Because **if** “we do not want to do this” – **then** we cannot proceed any further to fulfil Yahweh's Desire!

However, if we truly wish to fulfil Yahweh's Desire then this means:

We must have a desire: “**NOT** to self-indulge”.

Being counter to what:

“The World teaches us”, that yields “what we have now” (as an imperfect society)!

By logical consequence, then we as individuals within society must:

NOT to make ourselves as: “Number One”,

by ultimate extension not to: Aim to be a “Leader” interfacing in/to/with The World/Society!
NOT to treat our “Present Existence” as “We only have One Life, – so get The Most out of it now!”
 by ultimate extension not to: Aim to be “Taking” what we can get from The World/Society now.
NOT to follow the advice of our professional psychiatrists to “pamper ourselves”!
 by ultimate extension not to: Aim to “Nurture” a mind that will not hearken to outside “correction”!

The above worldly practice teaches us “the opposite” to be “Edifying our neighbour (often to our own hurt)”
 Therefore, perhaps by logical extension then:

“Yahweh’s Desire” to yield “a perfect society” into “The Eternity” would be:

1. Edifying our neighbour (often to our own hurt, in this present environment).
2. Not self-indulging ourselves (thereby to be taking “The Last/Least” within society now).
3. Be prepared to listen to self-correction and instruction (for our personal edification) from a reliable source.

This seems a logical deduction based upon what we witness around The World today!

Thus, from this inductive reasoning, and **if** we are truly interested in changing our environment so that we can achieve a future perfected society, **then** we should build two listings upon the three reasoned headings given above.

These headings would be:

1. How to Yield a Perfect Society

How to maintain the present society.

Drilling down to the lowest level would generate perhaps ‘1001’ lines to answer these two headings!

For us to be positioned to learn what is required to make the distinction between the two societies then we must become educated about what will generate “a perfected society”.

Therefore, “The Crux” is to gain “The Correct Knowledge”.

Without “The Correct Knowledge” on how to yield “a perfected society” – then we are personally: “Doomed”!

Secondly, if we refuse to act with fidelity to “The Correct Knowledge” - then again, we are personally: “Doomed”!

Why this rather long preamble?

What have we learnt?

1. “We only know” what “We know”
2. “We know nothing outside what we know”
3. “We can only make judgements based upon what we know!”
4. Only a person who “Absolutely Knows” is in the position to then make “The Absolutely Correct Judgement” (Provided this entity desires to make “The Correct Judgement”, and yet: If having “The Knowledge” this entity then freely chooses to make the wrong judgement, clearly this cognitive entity must have other “self-indulgent” reasons to inhibit “the operation of wisdom”).
5. No human in authority “Absolutely Knows” (based upon their output) and thus by necessity must go to a reliable higher Authority to “Absolutely Know”, to be then positioned to: “Make the Correct Judgement”.
6. We have reasoned that we cannot go to The World for “Knowledge” because “People”:
 - 6.1 Do not “Absolutely Know”.
 - 6.2 Even when having limited knowledge – choose to ignore what knowledge they have, and behave foolishly!
 - 6.3 Use what they know – to personally gain out of their neighbour’s hurt!

All the above leads to our present World’s woes of which we witness “in its completeness” today!

Inasmuch we do not have “a perfect society” today, and never had this possibility for the last some 6000 years of recorded history under ALL forms of “Worldly Authority”!

Thus, based upon precedence, – we shall never have it – without some External Input to “present Mankind”.

Therefore, for “a perfect society” to exist, then we must look towards:

1. The Higher Authority (above what we presently have upon The Earth, because all people on Earth have failed).
2. Extra-terrestrial Input (again, because all worldly leaders have failed in their own capacity).

So we must look to “God” to help us, - but there are so many sources to this “God” under so many names (as per the very limited listing given on the front page)!

Therefore, upon which manuscript purporting to represent “God” do we: “Pin our future”!

How do we know which manuscript truly represents: “The Absolute Authority” of The Universe?

As with anything - it comes down to: “Testing”!

We must personally take “knowledge” (from wherever it may come) and most rigorously assay/prove its validity.

Without doing this, then we can only operate upon: “blind faith”!

I have tested most religions of The World and realise that virtually ALL religious people operate in: “Blind faith” for the many reasons given above!

People have only accepted what “the Environment” has taught them, and never “thoroughly questioned” their religion’s validity! Because what is presented (being “The Lure of Religion”) is ‘nice for us’, who are part of The Grouping to make it happen around us, – it is “a group exercise” of a self-indulgent “feel-good” factor!

In the context of a world consisting of ‘horrible things’ occurring outside our close-knit community!

We supposedly have:

“Big Daddy” looking after-us because ‘we look after Big Daddy’ by showering praise at Him/(Her)!

It is a cosy symbiotic relationship made so by ‘the commander’ of the proceedings – “The Religious Leader”!

Obviously, there are the customs, community spirit, mystic myths (unsupported by rigorous testing, but only “hearsay”),

and the religious leader orchestrating the community – for which he/she receives his/her daily dues for a physical existence – to perpetuate this ambience of ‘worship and self-goodness’!

Apparently ‘all very good’ - as perceived by the deluded people within this grouping, by virtue of it being a ‘closed thinking community’ not looking outside this comfortable setup – else be excommunicated by The Religious Leader – because quite obviously the leader does not want ‘infection’ occurring within this comfortable symbiotic community! People are taught not “to look outside” and not “to question”, – else it would become clear that “what they believe” with ‘all heart and soul’ **is fundamentally flawed** - yielding “Blind Faith” - which wholly covers The Planet today! Interestingly, leaders of “Religion” seem quite able to toss around the claim “certain people are blaspheming”, but does “The Almighty God” of The Universe really needs self-proclaiming representatives to ‘defend’ Him; where this charge is actually levelled against people who speak against what the religious leaders errantly ‘teach’! Actually “blaspheme” does not mean what leaders of “Religion” erroneously teach us, but something very much deeper, as I very carefully explain elsewhere (please see my glossary on “FutureLife.Org”).

Therefore, I ask the reader to be honest with themselves when asked these valid questions:-

Could your religion be reduced to this?

Could you use “reasoned argument” to give “fundamental **testable** bed-rock” upon what you believe?

Could you bring someone around to your way of thinking - **based upon solid testable argument**?

Have you even considered the possibility that what you believe **is** “fundamentally flawed, and wholly weak”?

Because quite simply if you have not “rigorously tested” what you believe, then it could certainly be flawed, and most importantly it shows that you are **NOT** “interested in resolving the situation” to **truly please Yahweh**!

So, what would “The Almighty God” “Yahweh” think of you if you have not the desire to truly please Him?!

Obviously less of you, than if you truly made it your business to fulfil His Desire!

These are all very pertinent pointed questions that need resolving - if we truly want to fulfil Yahweh’s Desire!

So then:

Does what you believe reduce down to:

1. “Hearsay” from a person saying something, who said about something about something or someone ...?
2. Events that could be conjured up by a competent illusionist (claiming to represent “God” for worldly return)?
3. Emotion – being so dangerously deceptive – and easily manipulated by unscrupulous people, as leaders?

Where all the above could be orchestrated by a “Conman” living off what we may give him/her to satisfy our emotional needs - of so many different possible things.

Noting that Conmen by definition are so charming friendly people, able to disarm our defensive guard, who also operate in “Religion” just as they do in any other walk of Life - of which we can easily recognise in someone else’s religion and not our own!

A conman is always able to see a need and ensure they “competently fill the need” in a fraudulent manner!

So the reader should be competently able to explain why their leader is **NOT** a conman, because I can assure the reader it is **almost a certainty** that all leaders of “Religion” **are** conmen/conwomen to vary degrees, and this your specific leader **is a conman/conwoman**, not truly believing what they tell you!

Interestingly, The Bible is the only Religious Manuscript that **regularly** warns against “deception”!

Where, if “The Almighty God” is “The Pinnacle of Perfection” instructing us to achieve a similar ideal standard to yield “a perfected society”, then He would **regularly give** “The Warning” to us through His faithful scribes. By contrast, other religious manuscripts not sourced by Yahweh would have no need for such warnings (except to bind them unto the religious leader) – because “perfection” could not be achieved by their instruction. Instruction is designed to be varied in composition to gain different sections of society.

Hence, it is logical to assume “Religion” in all its multitude of facets suits the aim of any “Single Adversary/Satan” against Yahweh, where Yahweh has only “The One Perfect Route to yield Mankind’s Salvation”, which implies all “Religion” **is** ultimately sourced from Satan through his agents, and not Yahweh. Yahweh **only** operates through His “Early Adopters” of which I competently show elsewhere (“Exposition 2 - The Plan”) are in the ratio of about 1 person in about 90,000 people!

All this is The Result of “logical inductive reasoning”!

Furthermore, can the reader understand **why** this would suit the aims of other ‘Powers to be’?

I explain “why” elsewhere, and sadly, like duped pawns we duly capitulate.

And yet, some 2.5 billion Christian people (having no excuse, unlike people of all other religions) have ignored these repeated warnings (because they never personally read these warnings, to then harken unto them) and thus become wholly deceived by their religious leaders (who for obvious personal reasons) will not instruct their clientele over such detailed matters!

Except these worldly leaders misquote the warnings, so they may use these misquotes to enhance their present hold over their non-questioning devotees, all thinking they are on ‘the road to eternal salvation’. For the sole reason they have unquestioningly accepted at face value what they have been told. That reduces to a yarn presented with an inviting lure to be part of this salvation by simply (1) saying “I am a Christian” and (2) “I am doing good things” (that reduces down to only being “At least I am better than my neighbour” in perhaps an errant self-judgment)!

Like “worldly Christianity”, all “Religion” is taken at face value; nothing is explained or validated for “righteousness”. The difference between “1st Century Christianity” (as taught by Jesus Christ [= JC, from now on] and the apostles) and “Religion” (of which includes the schism “worldly Christianity” [that wholly covers the world today, in all its various sub-schisms]) is that what JC taught (sometimes for 3 days to the same grouping of people, Mark.8v2).

JC used “The Bed-rock” as given in The Tanakh (= The Old Testament) to underwrite what Yahweh is doing to righteously yield “The Salvation of Mankind” within “The Perfected Society” - to give validity by “**Strength of Argument**” which in turn, magnifies Yahweh as having truly Orchestrated everything in “The Most Marvellous Manner”!

All of which, if done, would then give real credibility to Yahweh within The Religions outside Christendom, to bring people within “1st Century Christianity”. To show that “1st Century Christianity” has reasoned validity/credibility to set it wholly apart from “Religion”.

This would truly project/magnify Yahweh’s glory/honour/dignity within sane/reasoning minds of humans (being what is supposed to separate us from animals [Gen.1v26, John.10v34-35])!

This is to ultimately occur within “a perfect society” - being “The Goal” of this reasoned dissertation.

However, leaders of “Christendom” have absolutely NO intention of doing this, often going out of their way to reduce the significance of The Old Testament (by some leaders, to be doubting its authenticity, in direct contrast to what Paul thought and taught of The Tanakh, 2Tim.3v15-17).

That is why Yahweh wholly rejects leaders of Christendom (= “The 2nd Epoch Israel”) in precisely the one/same manner He rejected on mass, the leaders of “Religion” of “The 1st Epoch Israel” (= The Jewish Nation during, and prior, to JC’s ministry).

The Crux of this document is that we must personally gain “Accurate Knowledge”, and the best place to start is from a good translation of The Bible. The “most available and only trustworthy Bible for its sincerity” is the KJV, though it has a few minor translational errors, but most importantly absolutely avoid the NIV (New International Version) like the plague, it is a bent translation at key doctrinal areas, being a “worldly interpretation”. Please see again, the beginning of this dissertation about a trustworthy source, because many modern bibles translations are: Worldly errant “interpretations” given to support an embedded worldly doctrine (and the worldly lifestyles of its protagonists)!

It is important to recognise (as I have explained earlier), worldly Christian leaders only need to have “just a bit more knowledge” than whom they are deluding within their flocks – to become the comen/conwomen to extract goodies from out of their clientèle.

Because it is only “a vocation to become a professional” to earn a worldly income of whatever (pulls their strings) noting what JC stated at Matt.6v24, 22v20-22, Luke.16v3, and Paul did by example at Acts.18v1-3, and what he taught at 2Thes.3v6-12 as a few examples of many that could be used).

There are several differences between our worldly Christian leaders and what I do, principally:-

1. I have expended some 50,000 hours of my own time in ONLY studying The Bible (and not man’s ruminations!)
2. I receive no income from what I freely give out to The World, – also I only use my own hard-earned money from secular work and use my personal time in teaching The World – so I am wholly objective to Yahweh’s Cause.
3. I demonstrably show agapao (edifying love) and not eros (self-indulgent love) to my readers by copiously explaining what Yahweh Truly Desires. I explain the specific righteous route that He is using through millennia to achieve His “Most Righteous Goal” which is “The Salvation of Mankind” through the most righteous means possible, thereby exhibiting The Fact: “Yahweh is Holy” (= Innocent/Blameless/Pure/{Separate from this world of sin} in all of His actions).

Therefore, I ask the reader:-

What leader of “Religion” can give such an equivalent **authoritative** claim?

The point of this is that I have absolutely no interest for worldly gain from what I explain - and all I will receive is abuse from leaders of “Religion” because my writings wholly digested in their entirety, exposes their hypocrisy to The World.

So what is my driver?

My “Driver” can only be “To fulfil Yahweh’s Desire to the very best that I am able!”

After ‘patting my own back’, not for self-praise, but only to cause the reader to carefully consider my motives are truly sincere and not fabricated/crafted for a worldly return – to keep “The Professional Religious Leader” physically alive. Therefore, like Paul, I will: “Tell it as it is” – and not give “a pleasant sales spiel” to endear and enthrall the listener (noting what Paul stated at 1Thes.2v3-6, Gal.3v1, and numerous other places).

Why?

Because I sincerely care for your long-term well-being (which requires personal reform for all of us). During my journey of investigation, I have recorded my reasoning and understanding of Yahweh’s Desire for future people to read, so that they too may understand and then endeavour to truly fulfil His Desire. It must be recognised, I may be dead tomorrow, but these writings will persist beyond, to edify future readers, after I have left the 1st part of my physical life. The point being made is this, I have no desire to gain anything from these writings for “the here and now” - and only desire to just: **“Tell it as it is”!**

Please let me: “Tell it as it is”:-

“1st Century Christianity” had to change into “worldly Christianity”!

Where:

“1st Century Christianity” used The Tanakh to explain Yahweh’s “Most Righteous Plan for Human Salvation” to give fundamental credibility to The Almighty God’s “Capability and Authority” to “get things done”.

JC freely gave to each one of us:

- (1) **The Ministry** to ‘purify our mind’ and
- (2) **The Ransom Sacrifice** to righteously ‘get us into perfect physical body’.

JC also became

“The Template” for “The Goal” of “Anointing” available for 144000 people who were/are truly driven by agapao (principled/edifying love) to yield agape (true unfeigned charity, = work given with no strings attached) in their life by becoming spiritual (and sadly, many of these people became physical) martyrs.

By contrast:

“Worldly Christianity” mutated within The 1st Century CE, to become fully endorsed as a “Religion” in 325 CE.

“Worldly Christianity” promotes the following (behind its professional presented public facade):

Worldly worship of ‘I will scratch your back so that you will scratch my back’ (ignoring Matt.6v1-8).

Wholly hypocritical mantra, which:

Endorses our present sinful state, because the buck is always passed back to: “JC always loves me”.

Whatever I may do I am always covered, so long as “I believe in him!” (Jude.v4)

Inasmuch:

“I believe he exists and that he died for me!”

Unto which

“I will receive everlasting life in heaven!”

I also know of a few ‘stories’ of what he did and ‘all this’, confirms that I am a Christian beloved by “God”!

This becomes a false gospel of “another Jesus” (2Cor.11v3-4) is given, where “salvation” is (supposedly) automatic without us having to really change our animalistic/carnal mind, - therefore these leaders promote:

“Business (the operative term) as usual”!

We are therefore able to reason:

When simply stated as given above, – then the dichotomy between the two becomes obvious!

We must recognise this truism.

The main reason as to why “Christianity” became the official “Religion” of The Romans was by the example of “The True Christian Martyrs” previously dying for a greater future good. The political leaders at the time realised this would be a useful driver to motivate The Roman Soldiers to fight unto death for “The Good Cause” (being the immediate “Cause for The Roman State” [and not for The Millennium, being Yahweh’s Cause for “a perfected Society”]). We conclude, the uptake of (worldly) Christianity into The Roman Empire was done solely for political expediency (a simple case of Religion and Politics becoming “hand in glove”, being how they have always operated).

Moreover, where do we read in The Bible about precisely the one/same thing occurring?

It is recorded at John.11v47-53, where worldly religious leaders make a pact with The World for self-indulgent expediency, without realising that their selfish aims were actually being used by Yahweh to righteously move forward His “Plan for Human Salvation”.

Noting that Yahweh causes no sin, He cannot sully Himself, but He exposes and uses man’s sin for a greater cause! I repeat, “Yahweh cannot Sin”, but He knows “How man will sin”, and He uses their sin to (1) exhibit their sin to The World, but in the process, Yahweh is (2) able to gain “righteous goodness” out of their machinations to yield “Mankind’s Salvation”.

The point being that in “The Culmination” Yahweh is able to show The World (after Luke.12v3):

1. “The Early Adopters” (being [1] The Prophets and [2] The 144000 TCs) wholly driven by agapao are the correct leaders to rule “The Resurrected World” in The Millennium.
2. “The leaders of Religion” (and worldly politics) throughout the “Two Epochs of Israel” (Jews, Christians) driven by a “feigned love” are wholly delinquent to rule “The Resurrected World” in The Millennium – and rejected from this position (perhaps more than half of JC’s parables specifically attest to this fact, please see my extensive commentaries to the four Gospels).

Let me ask the reader this question:

Can YOU start to see the deeper levels of how Yahweh is righteously operating, that exposes Himself in His operations throughout The Bible as being (infinite) orders of magnitude greater than what is written in other religious manuscripts (sourced by Mankind)?

Yet my some 4,000,000 + words of writing on “FutureLife.Org” only ‘scratches the surface’ to expose “The Infinite Greatness” of His Capability being exposed throughout millennia - that shall be explained to us in The Millennium.

But all this is what JC was teaching to The Public, and hence the comment at Mark.1v22.

It is by recognising Yahweh’s Greatness in “**Righteous Organisation**” throughout millennia that gives credibility to a sane/reasoning mind that helps us (as individuals) to make that required seismic change in our thinking processes.

For our ultimate salvation then we must break our link with “worldly thinking” smothering our mind (Eph.2v2) operating throughout “The Environment since our birth”. We must start “The Required Fundamental Change” in our mind (= our thought processes [spirit/personality/desires/traits/character]) to become wholly “Christ-like” (1Pet.2v18-24) without even having to ask the hypocritical question:

“What would Jesus have done in this situation?”

“Hypocritical” because if we truly had the one/same mind as Jesus, then we would not even need to ask The Question, – The Answer would be instinctive! We only need ask The Question because our mind is not The One/Same as JC!

At least it is getting onto “The 1st Square”!

Also “hypocritical” - because often the people who ask that question think that they have reached “The 100th Square”!

Yet they have only just started their journey!

What is worse – is our leaders of “Christianity” teach of their devotees having reached “The 100th Square” if they start asking that question! That is the basic problem we face today, and have done so for the last some 1900+ years! What people of The Gospel Age must understand, is that “the person” who is perceived by The World to be The Most “Good” in society today, will be actually “The Absolute Minimum Standard” for success in The Millennium, where “success” means “eternal life” for us, who are to be judged as individuals.

Some people reading this may be asking, “Get to the point”!

What I am showing is the following:

We cannot trust what we know (only because it has been previously accepted at “face value”).

We cannot trust what other people tell us (because they are very likely to have an ulterior motive).

We must go to a **demonstrably proven** “reliable reference” (**not** leaders of Religion) - for “The Knowledge”.

We must **test** “knowledge” to ensure that it righteously represents “The Knowledge” **as sourced by Yahweh**.

We must gain **workable tools** to untangle “knowledge” - to prove its authenticity and validity.

This practised route “demonstrably shows we are trying to attain and fulfil Yahweh’s Desire”.

(Matt.7v6-8)

I have very briefly explained that we must go to “1st Century Christianity” for understanding “The Knowledge” and of its application to gain “The Wisdom of God”. My website “FutureLife.Org” displays my journey of written rigorous assay of specifically The New Testament to gain assurance, from which I am duty bound to operate with fidelity upon what I have personally discovered (which is to teach The World of it).

It is only through this “3 Stage Process” are we able to gain “**Real** Faith”.

Where:- “**Real** Faith” = **Accurate** Knowledge + Assurance + Fidelity.

(Else it becomes “blind faith” if any one, or more, of the three above is not done).

We may ask:

What did JC teach us in “1st Century Christianity” that exposes “**worldly** Christianity” to be an unrighteous sham?

I have written a dissertation on explaining the difference between “1st Century Christianity” (as taught by JC and the apostles) and to that of “**worldly** Christianity” as taught for the last some 1900+ years which can also be read on “FutureLife.Org”.

But let the reader carefully analyse my writings and then personally consider the differences between what JC taught us as “1st Century Christianity” and what “Religion” teaches us in the form of “**worldly** Christianity”.

Yahweh throughout The Three Ages (under Satan’s present misrule) of:

1. Pre-covenants, prior to about 1900 BCE (up to Gen.12v1) giving “The Promise” of what was to come (Gen.3v15, JC from the womb of Mary, bruised in the heel [at his murder, but resurrected], shall then bruise Satan in the head [terminal destruction, Rev.20v12]). I thoroughly explain this elsewhere.
2. 1st Covenant (to yield “The Righteous Means” [JC] to enable “The Promise”) inaugurated in about 1520 BCE when Yahweh gave The Commandments to The Israelites through Moses. JC remaining perfect, made possible “The Promise” by enabling Yahweh to righteously resurrect us, humans (Christians **AND** non-Christians), into the 2nd part of our physical life (during The Millennium).
3. 2nd Covenant (to yield “Human Salvation” for The Eternity as part of “The Promise”) inaugurated in about 30 CE starting with JC’s Ministry, consolidated at JC’s murder 3.5 years later. JC became The Template for us to **personally modify our mind to precisely imitate him**, for us to **personally** achieve “eternal life”.

After these some 6000 years (as described above), “Extra-Terrestrial Authority” shall be exercised (Rev.19v16-21) that becomes “The Great Tribulation” (principally targeted towards worldly leaders who are **wholly ejected** from out of their present position) to close down Satan’s present misrule through his cohorts. “**Satan’s cohorts**” are “the leaders” **throughout** society “**operating according to his methodology**” that causes the present pain and suffering (= self-indulgence taken to its limit, Matt.24v22).

(Note: JC = Jesus Christ, TC = True Christians [these are people who precisely imitate JC’s ministry/lifestyle].)

Yahweh then offers “The Great Sabbath Day” (= “The Millennium” [of 1000 years] 2Pet.3v8) for us **to learn** how to purify our minds to yield “a perfect society” under “The Righteous Rule” of JCg (Mark.2v27-28) while he covered us over “The Great Sabbath Day” (John.19v31, 20v1). Where “JCg” is “JC in a heavenly/celestial physical body”. Noting that JCg will **enforce** “Righteous Rule” and operations during this time period (Rev.2v27, 12v5, 19v15, etc.). Those people during this covering period of “The Great Sabbath Day” who refuse to personally imitate JC (when profusely taught “The Accurate Knowledge”), shall be removed at the end of The Millennium (Rev.20v7-15) at “The 2nd Death” of annihilation (Rev.2v11, 20v6) because JC has **not** covered us “twice” as we read at Heb.6v4-6, 10v26-28, 2Pet.2v18-22, etc.

JCg’s assistants ruling over “The Resurrected World” are “**The Early Adopters**” consisting of:

- (1) “The Prophets” elected from out of “The 1st Epoch of Israel” (= The Jews) and
- (2) “The 144000 TCs” to become “**Fulfilled Prophecy**” (Rev.14v1-4) elected from out of “The 2nd Epoch Israel” (= The Christians) who come together at “The 1st Resurrection” (John.10v16, Matt.24v31, 40-44, 1Thes.4v13-18, 1Cor.15v50-55, Rev.11v11-13, 19v4-9, etc.)

That is a **very basic** high-level overview of Yahweh’s “Most Righteous Plan for Human Salvation”.

But “The Crux” of all this is that:

Before the some 6000 years of Satan’s misrule can close,

Yahweh **requires** His **demonstrably proven** righteous “Early Adopters” to become His “Tools” **to lead** “The

Resurrected World” unto “Righteousness” (Rev.14v1-4, 21v1-4, 2Tim.4v6-8, 1Pet.5v4, Rev.1v6, etc.). The specifically perfected individuals must prove themselves perfect to The World, - but certainly not to Yahweh (because Yahweh foreknew who these people would be before the foundation of The World [= “Life”] Eph.1v4).

Why do these “Early Adopters” need to underwrite their “Real Faith” through works?

The answers are very simple:-

1. Many people require their leader to demonstrate The Qualities that are being taught - else an immediate ‘us and them’ situation occurs – with the leader being deemed a hypocrite!
2. Yahweh must be seen to be “righteous” and unflawed. To this end, He is choosing for kingship by judgement upon the inner self (1Sam.16v7, in the context of kingship, 2Tim.4v6-8, 1Pet.5v4 as a “son of God”) based upon what these individuals must outwardly show The World during their lifetime. They must demonstrate to The World they remained entirely faithful to Yahweh’s Word even when persecuted by leaders of “Religion” throughout The Ages, (being worldly leaders pretending to represent “The Almighty God”, but ever so badly, hence Luke.20v16).
3. These “Early Adopters” must drive their own mind to be wholly humble/contrite/subservient to the present worldly authority within displayed works, to gain a mind that is likewise humble and subservient to Yahweh. In this manner these “Early Adopters” remain as faithful slaves in The Millennium with infinite “Authority, Capability and Power” to rule (but humility is hardly a quality that we witness within present day worldly leaders of politics, commerce and religion)!
4. In all works as “The Interface” to our neighbours, our actions must not bring a charge/case against us in The Millennium, where a disgruntled person rejected by Yahweh for Sonship (Matt.8v12, etc.) may not be in the righteous position to state, “I was not able to become a son of God, because of the actions of that person, of whom You made to be one of Your sons - that is not fair/righteous”!
5. The members of “The General Resurrected World”, upon close examination of “The Credentials” of “The Early Adopters” generated during the 1st part of their physical life (after Luke.12v3 has occurred) will state: I could not have done what “The Early Adopters” did in their life to underwrite their “Real faith”! Thereby they are personally substantiating their position to teach “Righteousness”.
6. These “Early Adopters” show they truly have “The Word of God” wholly operating within them, to create a new mind (= a new spiritual entity completely built upon JC as “The Word of God”, Gal.6v15, Rev.19v13) to be truly having “The Presence/Parousia of JC” operating within them. This is visibly demonstrated by their works of precisely imitating JC’s ministry/lifestyle to publicly prove themselves as truly having the holy spirit operating within them. Inasmuch “The Word of God” had become “personalised” within these Early Adopters so that their spirit/personality/desires/traits had become the one/same Holy/Innocent/Pure/Blameless/{Separate from this world of sin} Spirit/Personality/Desires/Traits as that which operates within Yahweh and JC (John.14v20, 17v21-26). All of which is “to make Yahweh’s Desire manifest within The Environment”. This explains the Holy Spirit as given to us in The Bible – and certainly not the nonsense taught by “worldly Christianity” throughout The World today.

As we can start to see from what JC taught us as “1st Century Christianity” and further expanded by the apostles is that we are to have a “2 part life” comprising of:

1. Old Spiritual life built upon worldly methodology (since our physical birth) being replaced by **The Ministry** as given by JC to give us a 2nd part spiritual life to be wholly built upon Yahweh’s Methodology as precisely exemplified by JC’s lifestyle (allegorically represented by ‘bread’ Matt.26v26).
2. Old Physical life (now) within a decaying fleshly body being replaced by a new physical body (given in trust [for (1) above to occur]). This is righteously possible because of The **Ransom Sacrifice** bestowed by JC to give us a 2nd part physical life so that we may righteously have everlasting life (to become a “conscious reasoning entity” [hence a “soul”, please see my glossary]).

This is what The Bible teaches us throughout, where we are operating within “The **Acceptable Year** of The Lord” (Luke.4v16-19), being an allegory used to represent “us” as “individuals”.

Winter is a time where we have no “Word of God” sown within the ground.

Spring is a time when “The Word of God” is sown within us.

Summer is the time when “The Word of God” grows within us to yield spiritual/physical fruitage.

Autumn is “The Judgement Time” for “The Harvest”, ideally into Yahweh’s Granary (Matt.13v30).

“The (metaphoric) year” is “**Acceptable**” because it is a “**Righteous process**” to yield “Human Salvation” by “The **Righteous** (Lord/Master) Yahweh”.

This “acceptable year” (as JC taught us) can either occur:

During the 1st part of our physical life, for us to become an “Early Adopter” and thus a demonstrably worthy ruler to become “The Heir” (= “son of God”) ruling/teaching over “The Inheritance” (= “The Resurrected World”, in The Millennium), or

It can occur in the 2nd part of our physical life (during The Millennium) for us to become a “Late Adopter” (as part of “The General [Resurrected] Population”) thereby being part of “The Inheritance”.

If we refuse to personally reform during these two periods within our physical life - then we are removed from society at what The Bible calls “The 2nd Death” (as mentioned at Rev.2v27, 20v6) - of which JC has not covered for us (Heb.6v4-6, 10v26-28, 2Pet.2v18-19, etc.).

Already what I have explained is so very far away, from what leaders of “Religion” teach us!

We realise they do **not** teach “righteousness”, but only teach of “goodness” (of which atheists equally teach) and of which religious leaders then fail to practise within their own life - thereby classing themselves as hypocrites (Matt.6v2-5, Luke.11v44, 12v1, noting Matt.23v1-3+).

We also realise two further important things:

1. JC gave all of us the means to achieve “everlasting life” – being (1) **The Ministry** to purify our mind and (2) **The Ransom Sacrifice** open to all people (both Christians and non-Christians, 1John.2v2, 4v14) so that we all may have a 2 part physical life.
2. Our long-term salvation into The Eternity over our “2 part life” depends solely upon us as individuals to: “ultimately imitate JC’s deportment”, by changing our thought processes to become exactly like our saviour.

That is “1st Century Christianity” as taught by JC and The Apostles, to yield the “1st Century Christians”, who themselves were heavily persecuted by “The Religious Leaders” working “hand in glove” with The Secular Authorities, (at the time being “The Romans”) to carry out their dirty work for them (John.19v12 having previously already made the decision at Matt.26v4).

So we may intelligently ask the question:

Why do we need leaders of “Religion” for our personal salvation?

Because “1st Century Christianity” teaches us:

1. **Only JC** gets us into the 2nd part of our physical life.
2. It becomes our **personal responsibility** to precisely imitate JC for our individual “eternal salvation”. Item [2] above can only occur by completely reforming our mind upon The Word of God” being of “**Its Power**” to reform what was previous a recalcitrant mind – and thereby to become the one/same as JC and Yahweh, John.14v20v17v21-26, hence our required repentance (and thus John.1v15, 23-26)!

Therefore, I repeat the question:

Why do we need leaders of “Religion” for our “personal salvation”?

Because we recognise within Yahweh’s “Grand Scheme of Things”, they are utterly redundant!

That is precisely what JC taught, and because of this teaching by explaining The Tanakh, the educated populace realised that “The Leaders of Religion” were really “parasites to the community” and could personally offer absolutely nothing to “**The Salvation of Mankind**”.

This is why “The Leaders of Religion” detested JC, and of his teaching (John.11v47-53)!

How could they make a worldly living - by living off the backs of people by only saying: “**Sweet Nothings**”!

They had been exposed by: “Strength of Argument” (Mark.1v22)!

However, “The Religious Leaders” of “The 1st and 2nd Epochs of Israel” (Jews and then Christians) were/are somewhat useful in Yahweh’s “Greater Scheme of Things” for one reason only. They did/do form “a continuum” out of which Yahweh was/is able to extract His demonstrably proven “Early Adopters” to become “The Rulers/Teachers of The Resurrected World”, as only elected by Yahweh (because of 1Sam.16v7).

“The Early Adopters” are not elected/chosen by leaders of “Religion” presumptuously deeming themselves to be “God” by electing His own sons for Him (as presumed ‘saints’ through “The Beatification/Canonisation Process”) **contrary** to what Matt.20v23 tells us!

Can the reader start to understand the gross distortions generated by leaders of “Religion” beholden to their myths, given only to extract a worldly return from their duped and deluded devotees (betting on eternal life)?

I am trying to make everything as taught “very stark” – so that we can all wake up to “The Realities” of what is occurring around us, and has occurred (unquestioned) for the last some 6000 years of recorded history, where actually, Yahweh is working outside “Religion”. Yahweh must work outside “Religion” to bring about “The Salvation of Mankind” through “The Most Righteous Process” as thoroughly explained in both The Old and New Testaments of The Bible that must be taken holistically together – for “The 3-Dimensional Picture” to jump out at us.

So, in answer to the Title’s Question:

What does God really want from us?

We know the answer is to: “Achieve a perfect society” into The Eternity,

In addition, we also know that it must be performed in “The Most Righteous Manner”, else some disgruntled individual will always state: “Something was not fair”, - and would otherwise sully Yahweh’s Perfection (if this accusation were ever proven true).

But how do we achieve this “perfect society”?

(Of which The Bible calls “Paradise/Park”).

We know that the closest we ever drew near to this eutopia (= a “good place”, while “utopia” means “nowhere”) was in the direct vicinity of JC’s operations some 2000 years ago. This was his 1st advent as a “lion cub” to lay down “The Righteous Ground Work”, but when he comes as “The Fully-Grown Lion” exercising “All Authority” at his 2nd Advent, then “All Righteousness” shall be physically/forcibly installed (Gen.49v8-12, Rev.19v15-21, 2v27, 12v5, and many other endorsing citations can be given).

We know that The Prophets were required to establish The Prophecies of which JC fulfilled – to yield his 1st Advent. But prophecies were also given at Rev.14v1-4 by “The Word of God” (= JCg, Rev.19v13) at John’s Revelation of what must occur before JCg can completely open “The Scroll of (guaranteed) Life” (Rev.5v1-10) enabling him to receive his bride of 144000 TCs (“Early Adopters” of the Gospel Age) to work alongside him (Matt.22v1-9, 24v31-44, 25v1-12, Eph.5v30-32, 1Cor.15v50-55, Rev.19v4-9, 21v2, 9, etc.).

The Seals as described in “Revelations” are prophecies of what must occur to The World during which time in parallel, the

144000 TCs are proving themselves “Righteous to The Requirements” to personally fulfil “The Prophesied Trigger Threshold” that shall ring forth “The 1st Resurrection”, and The Millennium 3.5 years later.
This is all thoroughly explained in my some 650,000 word dissertation of Revelations.
Most importantly – being “The Crux” of this dissertation:

These prophecies tell us Yahweh must achieve in a righteous manner a certain number of “Early Adopters” which must be fulfilled first in number - else by definition: “The Prophecy cannot be Fulfilled” and Yahweh therefore cannot righteous move forward to the next stage of His “Plan for Human Salvation”.

This next stage becomes “The Day of The Lord” comprising of many parts being:

- (1) of JCg’s 2nd Advent of “The 1st Resurrection” Rev.20v6, to gain his bride Rev.19v4-9, 21v2, 9,
- (2) The Removal of worldly operating leaders throughout of society, some 3.5 years later Rev.19v16-21,
- (3) The start of “The Resurrection of The World” some 40 days later, Dan.12v11-12, for Yahweh to the begin to purify The Resurrected Society over 1000 years of “The Millennium” Rev.20v6-7, teaching them “Righteousness” by His demonstrably proven (by works) “Early Adopters” (collected/elected over the past 6000 years).

As I stated, before this can occur, then Yahweh needs His prophecy fulfilled first!
Yahweh requires “The Trigger Threshold” of “144000 Early Adopters” who precisely imitate JC’s ministry/lifestyle, being what was commanded of us as individuals at Matt.28v19.
This is most important for us to understand:

When Yahweh has this quota, –

Then He can move to the next stage (= The Millennium = “The [Great] Sabbath”).

So, we may ask:

What is delaying this event from occurring?

Then the answer comes back to “us”, as individuals.

Where the question returns to be:

Are we actively trying to fulfil Yahweh’s Desire to make this future event occur (of “The 1st Resurrection”) by precisely imitating JC’s ministry/lifestyle (to become an “Early Adopter” as a future “Heir”) so Yahweh can ultimately achieve “a perfect society” (all the more sooner, by us, as individuals, shortening The Gospel Age)?
We can only do this by becoming one of The 144000 TCs (as only elected by Yahweh). Made so, because we have worked so hard (as explained above) in the one/same manner as did JC and Paul (driven by the one/same spirit only sourced by God’s Word) to gain the next generation of TCs for Yahweh’s Pleasure (Luke.19v16-19) to then shorten The Gospel Age. Can the reader recognise the righteous circular argument?

Furthermore, we may ask of ourselves:

What are we personally doing to make this wonderful event to occur?

Are we behaving like our (worldly) “professional” leaders of “Religion”?

Are we imitating what they do in their life (by being hypocritical)?

Are we listening to what they teach us - being that of “apathy” and “vain hope”?

Or are we:-

Actively learning The Scriptures in The Old Testament?

Actively learning The Teachings of what JC and The Apostles kindly gave to us – through personal persecution?

Actively assaying/testing “The Knowledge” from the two activities above, so that we gain assurance?

Actively operating with fidelity to “The Knowledge” gained and assurance generated by assay?

Teaching other people of the most wonderful interlocking knowledge that underwrites Yahweh’s Omnipotence?

Truly bringing real honour/glory/dignity/worship only to Yahweh within sane/reasoning minds?

We operating as slaves and take absolutely NOTHING for The Work that we do in magnifying Yahweh?

Driven by “The Word of God” for “The Anticipation” of “What is to be Expected” (= “The 1st Resurrection”)?

If we do the above honestly, then perhaps/maybe/possibly Yahweh will choose us to become one of The 144000 future sons of God to fulfil “The Prophesied Trigger Threshold of 144000 allocated places” alongside JCg (Rom.8v17, 23), and by consequence, personally increment forward in time JCg’s 2nd Advent to be an ever-nearer event.

“The Event in Time” that occurs when existing pain and suffering within The World (Rom.8v22) will be brought to an end (as we can read at Rev.21v1-4, to be perhaps some of the most beautiful words in The Bible).

Is that not to what we should all aspire to achieve?

What is wrong with trying:-

1. To fulfil Yahweh’s Desire, which is:
2. To yield a perfect society, in which ...
3. There is no more pain and suffering!

So we may ask:

What do our leaders of “Religion” teach us about what I have briefly covered in “1st Century Christianity”?

Quite simply (for the vast majority of Christian schisms):

Absolutely nothing!

Moreover:

When we analyse precisely what Yahweh Desires, being what “1st Century Christianity” teaches us then:

They are actively delaying “The Onset of JCg’s 2nd Advent” of “The 1st Resurrection”!

Because at 2016/8 CE it has not yet occurred and by consequence:

The members are not producing the next generation of TCs to achieve “The Prophesied Quota” of 144000 TCs. Therefore, by definition:

These leaders of “Religion” are opposing/adversarial (satanic) to “Yahweh’s Pure/Innocent/Blameless Desire/Personality/Traits being made manifest within The Environment”!

Furthermore, by opposing (= denying by rebellion) the holy spirit (which is Yahweh’s Pure Spirit being made manifest within The Environment “to achieve this perfected society ever sooner”).

We are also told in The Bible (Mark.3v28-29, Matt.12v31-32, etc.):

Anything can be forgiven, except to be blaspheming (= “deny by rebellion”) the holy spirit.

I write like this not to condemn (because I have no authority “to condemn”), but only to cause serious consideration of (1) what Yahweh requires and (2) how we are to personally achieve it, else I too will be condemned by Yahweh for remaining silent when I have “The Knowledge” (Eze.33v1-20), and I truly fear Yahweh Who is able: Luke.12v4-5! Therefore, the question taken from the proceeding pages must be this:

Are personally taking upon ourselves:

“**Ownership, Accountability and Responsibility**” with “The Word of God”?

This is what The Bible screams out to us within its pages!

After some nine pages of preamble, then let us consider what some Christians think:

It is not wise to speak out against leaders of “Religion” ...

It is God's business to sort out people who falsely claim to represent Him ...

God said He is going to do just that with the separation of The Sheep and Goats ...

He will sort out the wheat from the chaff ...

However, we can relax knowing God will have “The Final Say” over them ...

It's not our job to put The World right, it is His ...

People have the choice about what they believe ...

He gave people choice - He did not want robots!

Finally:

We are to become still, and silent with God’s Word ... !

The above seems reasonable at face value - being “**The Product**” of “worldly Christianity”.

Why?

Because “1st Century Christianity” as taught by JC and The Apostles is wholly unknown today!

Where, if “1st Century Christianity” were known today, then “Christians” would not be generating the confusing statements given above!

I have explained in the previous pages “The Basics” of “1st Century Christianity” which yielded “The Martyrs”.

“Worldly Christianity” has so comprehensibly diluted “Yahweh's Requirement/Desire” so that it has now become “hidden” (as stated by JC, Matt.5v15, Mark.4v21, Luke.11v33).

It is (let me repeat it again):-

1. The ultimate aim is to **RIGHTEOUSLY** produce “a perfect society” in The Culmination.
2. But before this can occur, Yahweh requires firstly to **RIGHTEOUSLY** elect/select His “Early Adopters” (Matt.20v16, 22v14) as “The Heirs” underwritten by their personal works, to become “His Tools/Slaves” to teach “Righteousness” to “The Resurrected World” in the one/same manner as did JC (as The Template). These are individual people (of whom we are to aim to be part of their grouping to fulfil Yahweh’s Desire). Where, “The Resurrected World” as “The Inheritance” comprises of all those people having lived (in the 1st part of their physical life) during the some 6000 years of human recorded history. They shall all be given their last opportunity to imitate JC's deportment while learning within an enforced perfected environment (Rev.2v27, 12v5, 19v15), ready for the final assay at the end of the Millennium (Matt.13v30, Rev.20v12-15).

This is true “righteousness”. It is also precisely: “What The Bible teaches us”.

That is precisely what our leaders of “Religion” do NOT teach us, as we witness from “The Confusion of Thought” given within the listing above.

Shall we go through this listing to unscramble their dishevelled minds of confused thought?

It is not wise to speak out against leaders of “Religion” ...

It certainly is not worldly wise to speak against professional leaders of “Religion” because we only need read in The Bible to understand what occurs to people who stand-up against “professional religious leaders” (Matt.23v37, Luke.13v34, John.11v47-53, 16v1-4, 2Tim.3v11-13, etc.). We can also think of people who were/are like William Tyndale, he was murdered by ‘people taking the high ground’ in religious matters (excusing themselves later at Matt.23v29-32, etc.). Yet it is spiritually wise to speak against professional leaders of “Religion” because we are taught by God's Word – to do precisely this (1Kings.18v21-22, Eze.33v1-15, Matt.5v15, Mark.4v21, Luke.11v53, Heb.5v12-14, etc.,) and Paul said: “Copy me as a copy JC” (Cor.4v16, 11v1, etc.) and he also taught in the one/same manner as did JC (please read Matt.23v1-36), which would be one reason why Paul was hounded by “The Jews” (= “the cohorts to the leaders of Religion”) during his missionary journeys (Acts.20v3, 21v11, 31, etc.).

So Yes in a worldly sense, I agree because ...

It is not worldly wise physically for “whistle blowers with conscience” to speak-up – because hypocrites will always respond aggressively - by virtue that nothing personally hurts so much as: “exposed hypocrisy”!

Yet No in a heavenly sense, I disagree because ...

It is wise with Yahweh if spiritually we are trying to fulfil Yahweh's Desire to bring forth the next generation of TCs so that Yahweh shall achieve His "prophesied quota" (Rev.14v1-4) progressively more quickly. Then it is demonstrably evident to The World that, "Only these specific individuals where/are sufficiently internally motivated to "lead forth" with God's Word correctly explained. They demonstrably show they had both "The Drive" and "The Fidelity" to accurately represent Yahweh's Interests, it is only this aspect that makes them suitable leaders to teach "righteousness" to "The Resurrected World".

As we are told by JC, we are to (**spiritually**) die (to worldly methodology that only gives **physical** death) so that we may (**spiritually**) live (within Yahweh's Methodology that shall give **physical** everlasting life), Matt.10v39, 16v25, Mark.8v35, Luke.9v24, 17v33, by imitating JC as "The Word of God" that yields Yahweh's Methodology within us.

It is God's business to sort out people who falsely claim to represent Him ...

Yes! Yahweh shall grade leaders of "Religion" into their respective categories before they enter The Millennium. The Bible tells us, that it shall not go well with the majority of them (Luke.12v46-48)! Many of JC's parables and illustrations teach us of their demise from positions of authority to teach "The Word of God". Please see my exhaustive commentaries of The Four Gospels.

Yet No! Yahweh requires people who claim to represent Him, to use "Strength of Argument" by having "The Authority to Accurately Teach" (The Bible allegory is: "fire from the mouth" Rev.11v5). This requires these people to thoroughly know The Bible 'like the back of their hand' - to combat deceptive half-truths (as did JC and Paul, Luke.2v46-50, Acts.22v3, 26v3-6, and we should be likewise). This is a spiritual fight (Eph.6v13-17) for us that requires much practice sparring else, we shall become hurt if not proficient! If we do not thoroughly know our subject matter then we could become like the members of The Public, being easily "wholly deceived", unable to differentiate between truth and lies (all of which The Bible [particularly The New Testament] so often warns within its pages).

God said He is going to do just that with the separation of The Sheep and Goats ...

He will sort out the wheat from the chaff ...

Absolutely He will, and it is most certainly not our responsibility to physically act in any manner against these people, and it is wholly Yahweh's Responsibility to elect/choose His representatives (as kings/priests in The Millennium). We are taught throughout Luke chapter 15 (for us acting as external catalysts) to bring wayward people back to their senses, - again by "Strength of Argument" based wholly upon Bible text, where this will bring about great happiness.

What is wrong with this?

It is those people trying to reform other people to become "precisely like JC" by only strength of argument, who show themselves to be "The Sheep" operating with one mind in "The Small Flock" (Luke.12v32, noting Matt.20v16, 22v14). Yahweh wants people who are convinced within The Mind as future New World leaders, not people who are pressganged into 'believing' as viewed from the outside; they are unstable and useless for future leadership roles in The Millennium. It is those people who refuse to reform and precisely imitate JC's ministry/lifestyle who become "The Goats" (= self-minded, Matt.25v32,41) rejected from becoming The Co-heirs (Rom.8v17, 23) alongside JCg (Matt.20v23) as "The Leaders" over "The Resurrected World".

It is not necessarily that "The Goats" are "evil", but only, that they are not suitable people to rule/teach righteousness, inasmuch having been rejected from sitting at The Table with Abraham, Isaac and Jacob (Matt.8v11, Luke.13v28) - please understand the full allegories of those three Entities being used as thoroughly explained in my cited commentaries.

However, we can relax knowing God will have "The Final Say" over them ...

Absolutely so! - Yahweh will completely reject them from a position of teaching "The Resurrected World" righteousness. As I carefully explain elsewhere "The Special/Greater (1st) Judgement" (James.3v1, see my local commentary) uniquely made by Yahweh is ONLY upon "Christians", where this "Judgement" can go one of three ways:

- (1) Resurrection as an "Heir" to be a future "son of God" (only available for 144000 people).
- (2) Resurrection as part of "The Inheritance", being part of "The Resurrected World".
- (3) Ignored in "The 1st Resurrection" (of [1] above), ignored in "The 2nd Resurrection" (of [2] above) = annihilation. Thus, people of (1) have guaranteed everlasting life (as "The Early Adopters", of "The 1st Resurrection" having proven themselves to have imitated JC, and shall remain so doing),

While those people of (2) have the possibility of everlasting life (as "The Late Adopters", of "The 2nd Resurrection", who must continue to imitate JC, else it shall become personal annihilation).

Yet the people of (3) are annihilated, having no existence to even realise they are annihilated. This is the unenviable future for the charlatan Christian leaders rampant today (Matt.24v23-26, Mark.13v21-23), at the close of The Gospel Age.

Importantly, it does become our responsibility with "The Word of God" to personally warn of what shall occur, else we are abdicating our responsibly and are not being driven by agapao to deliver agape to personally deliver people from out of (3) above and into (2); and those people of (2) ideally into (1).

Can the reader understand this very necessary requirement if we are aiming to be an "Early Adopter"?

Being "The Remit" to be repeated in The Millennium - so let us get the practise in now!

Else quite simply, we are not imitating JC's ministry/lifestyle (Mark.1v38, etc.), and not suitable for "The Role of Teaching Righteousness" in The Millennium - being Yahweh's "Ideal Goal" for us as individuals (Luke.19v16-19).

It's not our job to put The World right, it is His ...

Again: No and Yes! Being "the confusion" within the very many different strands of "Christendom".

No - We must never partake in political matters, and thus be entirely neutral in anything pertaining to The World.

I thoroughly explain precisely why elsewhere, please see my appropriate inter-verse commentaries.

While we cannot put The World right during The Gospel Age, it is our absolute responsibility to “Set the Required Standard” for “The Perfect Society” of The Millennium for other people to imitate, by (1) explanation and by (2) deed, in which manner we then precisely imitate JC's ministry/lifestyle. For us to do this, then we must gain “Real Faith” by the required 3 steps of gaining (1) Accurate Knowledge, (2) Assurance and finally (3) act with Fidelity to what we absolutely know.

Through this process we gain the next generation of TCs for Yahweh's Pleasure, and perhaps/maybe/possibly ourselves to become future “sons/children of God” (as only determined by Yahweh, Who can read our innermost thoughts, being what drives our output into The World [1Sam.16v7] as being genuine or feigned).

People have the choice about what they believe ...

A completely correct statement!

However, presently it is not righteous for all people to be finally judged upon what they presently believe! Especially for most “Christians”, let alone for all non-Christians, who never had a real chance to truly: “Believe in Jesus”, which requires “accurate knowledge” to then be righteously positioned to make “The Choice”. The vast majority of people require additional education in “The Ways of JC” first, before they are finally judged for “The 2nd Death”!

That is why we require “The Great Sabbath Day” (Mark.2v27-28) which is The Millennium (of 1000 years, 2Pet.3v8).

He gave people choice - He did not want robots!

This statement is very correct!

But not in “The Vanity” of “Worldly Christianity”!

Where we are taught by “worldly Christianity”:

1. “Love everyone”, but not taught what “love” really means (in its four different Greek meanings, and more sub-groupings) or taught that many non-Christians profusely love many different types of people in real charity.

And in typical hypocritical fashion, many self-claimed “Christians” do not display The Agape (charity) driven by Agapao (edifying love) formed by “The Word of God” reforming our mind (away from “self-indulgent love”). “Agapao” is “edifying love” to bring respondents to wholly fulfil Yahweh's Desire through its various stages.

2. We only need declare, “Jesus is our saviour and he died for us” to become a passport to “heaven”! This is complete nonsense!

Explanation:

We absolutely need/ed JC to (1) purify our mind by us imbuing his **ministry** to imitate him and (2) **ransom sacrifice** to righteously allow Yahweh to resurrect us into the 2nd part of our physical life (within which to do [1] for most people).

We do not go to “Heaven”, even the 144000 TCs return to The Earth in The Millennium (Rev.21v1-4).

Yahweh's Promise is for us to fill The Earth, and not Heaven (Gen.1v28, 9v1, etc.).

3. “Yahweh loves us”, “and is seen in all people”, this means we are: “Children of God”! More layers of nonsense!

Explanation:

Yahweh Agapao (edifying love) us as part of Mankind to ultimately generate “a perfect society”, but certainly He does not Phileo (attractively love) us in our present evil state (when having not wholly purified our mind upon His Word [= JC, Rev.19v13]). That is why we have The Intercessor JC (else, we would not need an intercessor, see also Ex.33v20). Only JC said he is the image and path to Yahweh (The Father) at John.14v5-15, and yet he did not say you can see God in him (anywhere). He even said: “No one is good (speaking of also himself in context), but only The Father (= Yahweh)” Matt.19v17, Luke.18v19. And thus, from this we are to only look towards The Father – and absolutely not to people “as our God” by inference (being the subtle “deviance” given by Satan's representatives – to mislead our thinking to ‘look unto’ worldly leaders). Finally, we are not “children of God” unless Yahweh states we are at “The 1st Resurrection”, when elected as future sons of God. No human today has The Right to declare us to be “Children of God” because in reality, we could be bastards (Heb.12v8), only Yahweh can see our inside to make that determination (1Sam.16v7 in the context for kingship [hence: son/child of God], Matt.20v23). We must realise this is subtle “deception” to mislead us (Gal.1v6-9, 3v1), by making us apathetic to ultimately becoming TCs (under the false assumption that we have already made The Grade as a “Child of God”).

I thoroughly explain these three sections within my inter-verse commentaries of The New Testament in much more detail, and need not repeat verbatim the very detailed righteous exegesis to differentiate between the deceptive half-truths and half-lies given above to mislead the devotees away from what Yahweh truly Desires.

We are to become still, and silent ... !

This is another great distortion - that has grown in favour within the last few decades amongst leaders of “Religion”!

It is so typical of Satan's cohorts (2Cor.11v13-15) to give an unexplained half-truth, to bend what Yahweh truly Desires!

Following same methodology Satan employed at Gen.3v1-5, Matt.4v1-12, all of which was recognised by the apostles.

The apostles warned of “sliding in alongside” a new gospel (2Pet.2v1-2) of excuses (Jude.v4) given by a new Jesus (2Cor.11v4), being “insidious” teaching of the new “worldly Christianity” that is profusely taught today.

We MUST know our subject matter to differentiate between “truth” and “deception”.

“Half-truths” is precisely how Satan operated (as cited above) towards Eve (Gen.3v1-5), and likewise towards JC

(Matt.4v1-12), and his cohorts in “Religion” for self-indulgent reasons behave in the same manner (2Cor.11v13-15).

The problem is that virtually no one reads to understand The Bible to “accurately know” what is in it, and thus they rely upon professional leaders of “Religion” to tell them, because it is easier and less demanding! And by mutual consent, the leaders only tell their devotees what the devotees want to hear (2Tim.4v3-4), so they keep coming back for: “The Weekly Fix/High” (for “The Emotional Mind”)! As would a drug-addict beholden to their drug pusher!

The Bible actually teaches us in numerous places that we should be replacing leaders of “Religion” ourselves in our own lay-ministry, and certainly never make a sole profession of it, else we cannot be objective (Matt.6v24, 22v20-22)!

Therefore, what does The Bible instruct of us (as the opposite to what leaders of “Religion” give in this quotation)? In the first instance:

The Bible teaches us to operate in “The Utmost Haste”, as if there is no tomorrow (because we must do what we can today), where we are taught to imitate JC and did Paul, and they both worked until exhausted, through all forms of hardship and persecution!

Is this what our professional leaders of “Religion” teach?

Hardly! For two reasons:-

1. They do not want to do it themselves! (So keep the devotees ignorant, unable to correctly judge the leaders).
2. If they instruct their devotees to do what The Bible requires of us, then they would walk away (John.6v60-66)!

And if they walked away, then how would professional leaders of “Religion” gain their physical sustenance?

In the second instance:-

Why be silent? Was JC or Paul ever silent when teaching “The Word of God”?

Would JC (or Paul) shut himself away in a monastery so that he could be silent?

Where would “1st Century Christianity” be if JC or Paul followed the advice of our leaders of “Religion”?

The answer is just so obvious, and does not even require me to write it down!

So again, we should ask: Who fulfils Yahweh's Desire, and who fulfils Satan's Desire?

Perhaps the instruction “to be silent”, is directed to us, so that we may not ask those awkward and embarrassing questions of our “professional religious leaders”!

I have only explained the above at a very high level, which should suffice to initiate the all-important personal in-depth questioning of what we are taught by professional leaders of “Religion”, of which the vast majority is just simply “wrong” when it comes to explaining “1st Century Christianity”! I recognise as soon as they stop quoting The Bible, then just about every second or third sentence that comes out of their mouth has a scriptural error within it (as I show in my audits of their publicly given sermons, of which I now have hundreds of dated transcripts to audit against specifically what The Bible teaches us)!

Let us now put my comments and explanations in context to “The Thrust” of “1st Century Christianity” as taught by JC and The Apostles, amplified in my several thousand inter-verse commentaries of The New Testament freely available on “FutureLife.Org” through The Internet to fulfil “The Prophecy” of Matt.24v14, and ideally yield Matt.28v19.

The point of this dissertation is this (for us to personally - because no one else can do it for us):-

1. Gain “Accurate Knowledge” by the daily reading of The Bible (use the KJV and absolutely not the NIV).
2. Rigorously assay/test/prove this knowledge to thoroughly understand its “Righteousness”, and gain assurance.
3. Then operate with the utmost fidelity upon this knowledge, which we now wholly understand through assay.
4. From this, we understand “Yahweh's Desire” which is to:
 - 4.1. Firstly, gain His proven “Early Adopters” to become Yahweh's Tools to perfect “The Resurrected World”.
 - 4.2. Secondly, achieved “a perfected society” in “The Most Righteous Means Possible”, so that no charge (from any entity) can be laid against “Righteous Yahweh” within “The Culmination”.
5. From the above we gain a 6th sense to spot “deception” pandemic through “rotten/decrepit Religion”, that goes wholly against “Yahweh's Pure Desire (of 4 above) to be made manifest within The Environment” (hence against the “Holy Spirit” [being of it correct composite definition as given on “FutureLife.Org” and not the nonsense as taught in Christendom]).
6. It is by recognising “deception” that protects us from insidious religious teaching that stops us from becoming a possible future son of God. To recognise “deception” then we must become “educated”! Quite simply “we are not perfected” if we have opened ourselves to a valid accusation from some member of “The Resurrected World” as not being suitably qualified to be of equal status as a brother/sister (of spiritual DNA) of JCg, to be Co-heir alongside him (Matt.12v48-50, 20v23, Rom.8v17, 23, etc.).
7. Counter to what we would naively think, Leaders of Religion absolutely do NOT want us to become educated in “The Word of God” (Rev.19v13) but only in “The Word of Man” (noting Paul's comments at Gal.1v10-12)!
8. Therefore, if we listen to leaders of “Religion” (“The Most Deceptive” being “worldly Christianity”) then we delay the onset of The Millennium, and we are thus “adversarial” to “Yahweh's Desire being made manifest within The Environment” (= adversarial to the “HS”). The reason why “worldly Christianity” is most dangerous, is that its deception is “not obvious” (being of “a new/another Jesus” 2Cor.11v4) being “A Gospel of Excuses” (Jude.v4), hence “The Great Harlot” (of Rev.19v2) spawned out of “Religion” as the metaphoric “Babylon” (the mother of [three] harlots [Judaism, Christianity, Islam] Rev.17v5, 18v2+).
9. It is “worldly Christianity” perpetuating “The Myth” that because:
 - (1) JC died for us [true] - then by consequence
 - (2) we need do nothing [false] because
 - (3) JC has done it all for us [half-truth]
 - (4) and so giving us “Christians” everlasting life [may be possible] by virtue that
 - (5) we “believe in JC”, inasmuch he is “the son of God”, “died for us” and we say/sing beautiful things about him to God [sadly, that is just “not good enough”],
 - (6) means “we are loved by Yahweh” [it is only agapao, not phileo and certainly not storge]!

The above makes “Christians” “hypocrites” and intrinsically despise what JC did if they think in such a shallow manner of what JC so kindly did for all of Mankind (both Christians and Non-Christians alike)!
Where, by explanation:-

- 8.1 JC freely gave The Ransom Sacrifice for all humans (irrespective if a Christian, or not) a 2 part physical life
- 8.2 We must purify our minds to become precisely like JC (the Early Adopter imitates JC's ministry/lifestyle).
- 8.3 JC has 'only' (in great personal pain/stress) given us (1) a 2 part spiritual life and (2) a 2 part physical life.
- 8.4 Only “The Early Adopters” gain “guaranteed everlasting life” because they truly “purified their mind”.
- 8.5 “Believe” means “Act with Fidelity” to “Proven Accurate knowledge” (see my commentary at John.6v64)
- 8.6 Only “The Early Adopters” “precisely imitating JC” are presently “loved by Yahweh” (agapao, phileo and storge) as His future sons – in the one/same manner that Yahweh **beloved** JC (Matt.3v17, 17v5, etc.).
10. No! Item (8) just makes us, claiming to be “Christians” in Yahweh's Judgement to be: “**Bigoted hypocrites**”.
- This being precisely “The Charge/Accusation” JC made against The Pharisees!
11. What JC has done for all of us is get us onto “The 1st Step of Salvation” by (1) Ministry (2) Ransom Sacrifice.
12. “The Remainder” that is required to achieve “Salvation” is personally dependent upon “us” **as individuals!**
13. “Worldly Christianity” excuses “The Need for Personal Reform” to imitate JC (alien to Yahweh's Desire).
14. “Worldly Christianity” blames other people for our own sinfulness (while we ignore our sin)!
15. “Worldly Christianity” denies our own personal responsibility to bring about personal reform!
16. It is for these three reasons Yahweh wholly detests “Worldly Christianity” that actively delays “The Onset of The Millennium”, under the deception that it supposedly ‘fulfils’ Yahweh's Desire, and thus prolongs the present pain and suffering within this world (Rom.8v22)! How bad is that distortion from them!
17. Yahweh detests “deception” that precludes The Requirement from achieving His Sons of God.
18. Yahweh detests “deception” that excuses The Requirement from precisely imitating JC's ministry/lifestyle.
19. Yahweh detests “deception” that pretends we are “children of God” when we are not!
20. Yahweh detests “deception” that falsely claims that He “loves evil” (being “unrepentant humans”)
21. Yahweh detests “deception” of putting on “rose coloured glasses” to view our present disgusting state!
22. Yahweh detests “deception” of presumptuous self-indulgence in what we do is correct, (when it is not).
23. Yahweh detests “deception” given as ‘truth’ by leaders of “Religion” sequestering what belongs to Yahweh!
24. It is this “deception” that “unrighteously obstructs” what He is building to achieve: “a perfect society”

The Crux of this piece is to show (repeating it for the umpteenth time):

Yahweh must **first** gain His “Early Adopters”, else He cannot proceed to purify “The Late Adopters” in The Millennium.
Thus, ANYTHING that delays this “Prime Requirement” is **adversarial** to Yahweh's Desire!

Where by definition, this is “Blaspheming against the HS” (Mark.3v28-29, Matt.12v31-32), noting what this terminology really means as carefully explained on “FutureLife.Org” and not what leaders of Religion tell us!
“The Early Adopters” of The Gospel Age, by definition must precisely imitate JC as “The Word of God”, else quite simply by definition, they cannot become “The Early Adopters” of “The Word of God” (Rev.19v13). This is Yahweh's Requirement (else obviously Yahweh would not have dispatched “The Word of God” to instruct us on how to precisely behave to ultimately become: “Beloved by Yahweh”, Matt.3v17, 17v5, etc.).

Does this sound logical?

Is what I have taught: “Righteous”?

Is it what: The Bible teaches us?

Then why do our leaders of “Religion” not teach it, but all manner of (1) excuses and (2) present self-indulgence!
The answer is obvious: – They cannot make a worldly return by teaching “The Word of God” (to imitate JC).
I keep repeating myself, – and if the reader finds it difficult to make the transition to become an “Early Adopter” then he/she has need to wait until The Millennium, when “The Mind” can be receptive for this “Knowledge” that is “The Only Knowledge” able to produce “a perfect society”. It shall require “The Enforced Perfect Society” operating all around us to become the catalyst required to promote “The Required Mind Change” enabling us to be wholly part of this future society.

Where Yahweh's Methodology (= edify our neighbour [perhaps to our own hurt]) operating within The Millennium in the 2nd part of our physical life shall supersede Satan's (worldly) methodology (= self-indulge to our neighbour's hurt) that presently operates in the 1st part of our physical life and has done so for the last some 6000 years (as history testifies).

That completes the third exposition, please now read “What did Jesus Christ and The Apostles really teach?”, in my fourth exposition, because Jesus and The Apostles certainly did not teach what leaders of Christendom teach us today!
