

My Introduction:

Let us be dispassionate and remove “Religion” out of the equation – so that we do not become ‘snarled-up’ on what is (unreasoned) “emotion” that fills “Religion”, to the shame of its leaders.

If there is an Almighty God (Who I call “Yahweh”) – then what would “That Entity” desire for us?

Let us assume for the moment, there is an Almighty God having created The Universe and of its most wonderful laws, which gives “order” to what, could be “chaos” – inasmuch we can calculate what is to occur and how things perform through mathematics, physics and chemistry.

This seems like “Order” to me, by *de-facto* I am physically able to write this (using a computer and how it operates, and is constructed, all based upon “order”)!

Then we may reason, “The Almighty God” as “It”, would not like to see “disorder and hurt” in a reasoning species, being a species that can reason and think “like gods” themselves (Gen.1v26, John.10v34-35). It would go ‘against the grain’ of what has been previously established – being what has been passionately created over billions of years previously. It seems logical to assume there should not be a disjunction between what was originally established and to what should proceed forward into the future!

Therefore “The Almighty God”:

If having a desire to see “order and perfection” (where “perfection” means “happy, healthy, comfortable”) for **all** members of society,

Then “It” (= The Almighty God) would intervene in a perfect manner to remove “disorder and hurt”.

Noting:

“All members of human society” means “Everyone” and not simply specific members of society who take from other people and push other people down – resulting in both groupings not to be in a perfect society.

Let me ask The Question:

If we put ourselves in the position of The Almighty God, does this sound logical so far?

If this sounds logical then we can continue this thought experiment!

If it does not sound logical, then perhaps the reader could contact me and explain why this is not a logical thought process.

Continuing with our reasoning:

If “The Almighty God” (as a Neuter) does not like witnessing “disorder and hurt” then “**It**/(Him/Her)” would be impassioned to righteously (thereby receiving no criticism to) change “disorder and hurt” to “order and perfection” within a society. Where this “society” has members, who can “reason like gods”, to become of similar mind (yet not in capability) to be likewise suitably impassioned to operate under a methodology of “order and perfection”, else it becomes “painful”!

Note: The Almighty God could have chosen to bypass this scenario, by making perfect humans who act like automatons (with no free will), but instead He gave humans the ability to make decisions for themselves (“like gods”) about how they interact ([initially negatively]/[then positively]) with their neighbour into The Culmination.

This seems like a “**learning process**” – does it not?

To make a freely considered (= educated and hence righteous) decision upon one’s future requires both sets of input:

1. From a society (of Today) that operates in “disorder and hurt” (= “painful”).
2. To a society (of The Future) that operates in “order and perfection” (= “pleasant”).

After having both the positive and negative experiences of each society, then any individual within a species can make a valid decision upon what methodology they prefer to operate within, as worked out within each type of society.

“No accusation” of “Unrighteousness” can be levelled at “The Almighty God” making possible this process.

Their future is now determined by their “own educated decision”.

Importantly it is seen by all entities (who themselves can “reason like gods” in any part of The Universe) that a **fair “decision making process”** has taken place, that yields “contentment/peace/satisfaction”. “Most Importantly” it can be universally seen “The Almighty God” overseeing this process and making all this occur – over a period of millennia (being the period of “The Specific Species”, whose members can “reason like gods”) is “Most Righteous” and no blame/charge/accusation can be levelled at “Yahweh” by any sub-member within The Universe.

Does this not sound **righteous**?

Does this not sound **logical**?

Now we have gone through a logical, intelligent and righteous thought process – then let us briefly consider “Religion”, only “very briefly”, because “Religion” in all its manifestations is not logical, nor intelligent and not righteous in how it operates – thus logically, “Religion” in all its schisms cannot be sourced by The Almighty God.

Except by contrast, what I term “1st Century Christianity” which is never taught today by either word or deed. M
Where “1st Century Christianity” comprises of:

1. The foundation of The Old Testament that teaches us of:
“**The Nature of The Problem**” and “**The Righteous Means**” of how “**The Problem is to be solved**”.
Where “The Ultimate Problem” is: “The Annihilation of a species that can reason like gods”.
2. The New Testament explains how “**Human Salvation**” is “**Righteously Achieved**”.
How “The Person” can achieve “The Goal”, and becomes “The Means to solve Human Salvation”.

By contrast, “worldly Christianity” covering The Planet today, only teaches “Religion”.

Within which, the very best goals for society – could equally be taught by an atheist, being an atheist having intelligently reasoned upon both the ‘teachings’ and shenanigans of “Religion” and accurately concluded it **not** being representative of an Almighty God. In addition, by inductive reasoning within a sane mind based upon “The (Worldly) Evidence” concludes “The Almighty God” does not exist!

Where one notable atheist having examined “Christians” publicly stated, “The last Christian died on the cross!”

Quite simply:

“Religion” must exist for its leaders to personally gain out of their deluded devotees (John.11v47-53)!

The “deluded devotees” sincerely want to do the correct thing, but are stopped by their leaders of “Religion” (Matt.23v13), because the devotees are **not** taught to know “what they should be doing”!

If we are to assume that we want to ultimately have a perfect society, then it is reasonable to assume The Almighty God would use this route as postulated above to bring this about by what JC taught as “1st Century Christianity”.

Therefore, by contrast, the present situation generated by leaders of “Religion” nullifying this route, is a detestation to “The Almighty God” Who rejects all of them to be representing His Interests.

Presently “The Almighty God” Yahweh **only** has interest in His **“Early Adopters”** who precisely fulfil His Desire.

This is hardly what our leaders of “Religion” are likely to teach - in their comprehensive “**deception**”.

“1st Century Christianity”:

This dissertation perhaps should have been called:

What is the difference between “1st Century Christianity” and “Worldly Christianity”?

Where:

“1st Century Christianity” is “Yahweh’s Methodology” as taught by JC and The Apostles.

“1st Century Christianity” **righteously answered** The Tanakh (= The Old Testament reformatted).

“Worldly Christianity” is “worldly methodology” taught by humans to become a subset of “Religion”!

“Worldly Christianity” is a means for “Leaders” to extract a living from out of deluded devotees.

Jesus Christ (JC) and the 1st, 2nd generation apostles taught “1st Century Christianity” which was quickly morphed into “worldly Christianity” by “professional religious leaders” to become a subset of “Religion”, and remained as such for the last some 1700+ years, when further endorsed at Nicea in 325 CE.

I thought it prudent to write this because after some 15 years of generating the most accurate translation of The New Testament on this planet, and likewise producing inter-verse commentaries that precisely explain the nuances operating within the minds of the scribes – I introduced this term “1st Century Christianity” in my 3rd Revision.

After spending over 50,000 man-hours on this topic alone, in my spare time outside my secular working week of some 50 hours, I now clearly understood the difference between the two terms.

Having the advantage of my secular income being outside “Religion” then I am **not** beholden to “two masters” (Matt.6v24, 22v21) for my fleshly existence and thus I **can** be objective, also non-partisan (Matt.22v16, James.2v1-12, Acts.10v34-35), thereby once learning and understanding the material, I am able to become a competent auditor **‘outside the department’** (of “Christianity”) being audited.

That is my background, and my credentials are the resultant of my most visible work on “FutureLife.Org”!

Quite simply:-

“1st Century Christianity” is “Yahweh’s Most Righteous Method to ultimately yield a Perfected Society”.

Conversely:

“Worldly Christianity” is “Religion”.

Where my definition of “Religion” is quite simply:-

“A means to extract gifts for the leaders from out of deluded clientele by the use of myths and lures (hearsay)!”

Obviously, “Religion” comprises of the very necessary aspects to survive:

1. A theme that leads to an ‘ideal’ (which may be quite perverse and certainly not righteous to all “humans”).
2. Often has “The Front Man” in the distant past – who came up with ‘The Idea’!
3. Subsequent leaders using “The Front Man” or “The Idea” as a means to substantiate their own position.
4. These leaders climbing to their levels in ‘the pyramid’ to gain from out of people below, supporting the edifice.
5. Maintain a ‘family’ as a supposed comforting protection from “The Big Bad World” outside ‘The Group’.
6. Any (dangerous) dissenters are called heretics, at best ostracised, at worse murdered (questioning is banned).
7. The leaders are then able to ‘divide and rule’ their patch for ‘the returned’ gifts and favours (= ROI).
8. Keep the echelons in place by myths and customs – of small things amplified, important things ignored.
9. A presupposition to ‘be good’ (but with underlining ‘mitigating circumstances/excuses’).
10. Most importantly, express the word “love” between people (but do not explain what this word really means). (Why? Because in reality, “Real Love” would show the leaders did **not** ‘love’ their gifting clientele).

I can state the above, based upon over 50,000 man-hours contemplating what “Mankind” is generally like behind “The Crafted Facade” produced by “Religion”, while getting into the very mind of the writers of The New Testament.

The point of Yahweh’s Plan as given in both “The Old and New Testament” is:

“It (= how Mankind operates) should not be like this!”

Furthermore:

“It will not be like this - at The Close of Yahweh’s Plan for Human Salvation!”

All this is explained in “The Most Meticulous Manner” in The Bible over what I term: “Two Epochs of Israel” (= The Jews and then The Christians), which shall ultimately yield “The 3rd Epoch Israel” (= “The Resurrected World”).

Where “Israel” means:-

“Persevere with Subjector”

Where “Subjector” is “The Specific God” (of The Context).

I use this term “The Specific God”, given in The Tanakh as “el” and in The New Testament as “ho theos” (“nominative” case) are relative terms based upon The Context.

By contrast, “Yahweh” [Tanakh] and the dative, genitive and accusative cases of “theos” [New Testament] are always absolute terms for “The Almighty God”.

Understanding these terms in The Bible suddenly turns the 2D written text into a 3D vista of Yahweh's most-righteous “Plan for Human Salvation”. This, and many aspects I discuss in my writings, are unknown to our religious scholars. Sadly, this knowledge is 'whitewashed' out in our English translated bibles to become “invisible”, and consequently hides the 3D vista of Yahweh's “Plan for Human Salvation” over some 6000 years. This being the period of time that “humanoids” could “reason like gods” (Gen.1v26, John.10v34-35) after the direct creation of Adam/Eve to become 'something special' over and above what previously walked The Earth on two legs for the previous some 100,000 years (noting specifically Gen.4v14-17, always ignored by Christian scholars and theologians alike).

Thus, once having “The Word of God”, then this grouping of people (“Israel”) can be split into two groupings:

1. People who “Persevere (**positively**) with Subjector”
2. People who “Persevere (**negatively**) with Subjector”

That is why Yahweh insisted Jacob change his name to “Israel” (Gen.32v28) to become “The Lead” for “The 3 Epochs of Israel” that were to follow in his wake. We are not specifically speaking about “worldly Israel” but “Israel” as determined by Yahweh, being “a grouping of people having His “Word of God” specific to “The Era/Epoch” within which a dichotomy can be righteously established within that specific grouping”.

I could write 100 pages now by expanding this theme through the generations of peoples and accounts within The Bible – but I cover that elsewhere in my exhaustive writings to show The Very Righteous unfolding of Yahweh's Plan throughout the millennia of time. This Plan that marches on, step by step, “having breadth and depth” is like the lattice structure of diamond to form the most rigorous exegesis to show “The Plan” as given in The Bible is flawless (and yet is absolutely never taught by the advocates of “worldly Christianity”).

Understanding all this within a sane/reasoning mind truly exhibits Yahweh's glory/honour/dignity.

This route perfectly describes:

“1st Century Christianity”

It is the exegesis by words and physical actions in deeds of “1st Century, Christianity” that JC carefully explained during his 3.5 year ministry period, day after day after day to the one/same audience (Matt.15v32, Mark.8v2).

JC methodically explained how:

“The Old Testament” was to yield “The 3rd Epoch Israel” (= “The Resurrected World”) through “The 2nd Epoch Israel” (= “The Christian Nation”). Why/How?

Because Yahweh was moving-on from “The 1st Epoch Israel” (“The Jews”) having yielded The Prophets (= “The Early Adopters”) and JC's 1st Advent, by fulfilment of much prophecy (given in The Old Testament) hence the rejection by “The Leaders of Religion” (John.11v47-53).

Where, it is:

“The 2nd Epoch of Israel” to yield the 144000 True Christians (= TCs, to be “The Early Adopters”) who personally fulfil prophecy (Rev.14v1-4) that shall yield JCg's 2nd Advent at “The 1st Resurrection” (Rev.20v6), which then becomes the next step of “Yahweh's Most Righteous Plan” to yield “Mankind's Salvation” over our “2 part life”.

We must understand:

“The Early Adopters (= the 144000 TCs) of **The 2nd Epoch Israel**” (= Christians) have “The Example” (JC) upon which they have the opportunity to precisely imitate, to become successful in “The Goal of The Anointing” as a future “son of God”.

By contrast:

“The Early Adopters (= the Prophets) of **The 1st Epoch Israel**” (= Jews), – but the prophets had not “The Example” (Matt.13v17, Luke.10v24, 1Pet.1v10) noting they are able to become the princes (Psm.45v16) because of their coverage by the TCs (Heb.11v40).

Yahweh requires these two groups of “**The Early Adopters**” (= The Prophets and 144000 TCs, John.10v16, please see my most accurate translation and commentary – and not that given in ‘worldly translated bibles’ dumbing-down “The Original Greek”, that sadly hides Yahweh's Most Righteous Plan).

These “Early Adopters” of the two earlier Israels shall become The Leaders for “The New Israel”.

“The New Israel” shall be “The 3rd Epoch Israel” of “The Resurrected World” where all humans (1John.2v2, 4v14, etc..) of the some 6000 years shall be resurrected to a judgement of life or death that shall occur over the 2nd part of our “2 part life” being both a “2 part physical” and “2 part spiritual” “life”.

Sadly, our worldly Christian theologians have completely missed 'the point' by repeatedly passing God's Word through “The Mincer” of Rev.22v18-19 within their minds by ignoring Prov.3v5-8, and without cause, falsely assume that this 'resurrection to a Judgement' of life or death is an “**instantaneous**” “Judgement” when actually, it is absolutely nothing of the sort!

The Bible teaches us that it shall be a period of 1000 years (Rev.20v3-7, please see my 17000 word commentary at Rev.20v5 that explains specifically why the first sentence is copyist addition) where “Judgement” (“Krisis” Strongs™ =

2920) is a personal “Crisis” because we are now in the last part of our “2 part life”. It is during what could be the last part of our existence, where we must personally make “The Correct Decision” to be “successful” - to achieve “life”, else “a failed decision” means “death” being “everlasting death” = “annihilation”.

We all shall have the 2nd part of our physical life, to righteously exist within a 1000 years period and become educated on how we are to personally transform our mind away from “worldly methodology” (= to self-indulge to our neighbour's hurt) unto “Yahweh's Methodology” (= to edify our neighbour to our own hurt, mutually practised throughout).

All this was as taught to us by the demonstrably proven “Early Adopters” (Luke.13v34, Heb.11v38-40, John.16v1-4, 2Tim.3v11-13, etc.) having precisely fulfilled Yahweh's Desire (hence operating according to His Methodology during the 1st part of their physical life - Luke.17v21).

It is essential for the reader to read my cited local commentaries to understand what really is occurring within the environment at the close of The Gospel Age (Matt.24v14).

Noting that JC only died “The Once” to get us “correct to Yahweh”, he has not died 'more often' for repeated parts of our future life (Heb.6v4-6, 10v26-28, 2Pet.2v18-22, etc.) - we only have a “2 part life” where the 2nd part is covered for a maximum of 1000 years (= “The Great Sabbath Day” Mark.2v27-28, Rev.20v3-7, Heb.4v4, etc.), beyond which we have no cover - we must have perfected our Mind to then continue into The Eternity.

We need nothing more because:

1. We have JC who has righteously covered:

(1) The 1st Part of our physical/spiritual life to get us into The Millennium.

(2) The Millennium, while we learn what a perfect environment is like during which time we purify our minds.

2. We, as individuals:

(1) Have presently experienced an evil society “The 1st Part of our Physical Life” during Satan's 6000 year tenure.

(2) Shall experience a good society in “The 2nd Part of our Physical Life” in The Millennium covered by JC.

From this freely given “Opportunity” we can be educated to personally reform our minds in The Millennium, if, for whatever reason, we were not able to do it in the 1st part of our physical life to become an “Early Adopter”, noting specifically the warning given by JC to “Christians” of The Gospel Age by allegory at Matt.11v21, Luke.10v13.

What more do we need or want?

That is “True Righteousness” never taught by worldly Christianity today!

That is the barest “Outline” that, explains my definition of “1st Century Christianity”.

My inter-verse commentaries (and other original work of some four million words) provide all the interlinking support structure that JC and the early apostles taught as “1st Century Christianity” that brings true honour/glory/dignity to Yahweh within a sane/sober/reasoning mind. A mind that “takes” the contrite/humble position to embark upon the long road of personal reform - being the process of becoming “Born Again” after conception of “The Word of God” growing within a repentant, hearkening mind.

This process first occurs within The Mind (John.3v1-12), which itself is metaphorically a foetus of the new ‘spiritual creature/creation’ growing within us (Gal.6v15), being built upon the metaphoric RNA of “The Word of God” that was originally explained to us by JC (Rev.19v13) when he taught us by both word and deed to become “The Wisdom of God”. Where, “wisdom” is “the accurate application of knowledge within our life” and thus we can have “worldly wisdom” that ultimately leads to “Death” (= “The 2nd Death” of “annihilation” by counter at Rev.2v27, 20v6), or “Godly Wisdom” that ultimately leads to “Life” being the continuation of the 2nd part of our physical life.

Finally, another thing our worldly Christian theologians do not understand is this:

The New Testament accurately translated, tells there are to be two distinct and separate “Judgements” made on the 2nd and 3rd Epoch Israels (= The Christians and then The Resurrected World [comprising of non-Christians and about 99.9% “failed Christians”]), because the only individual who passed Yahweh's Judgement in “The 1st Epoch Israel” (= The Jews) was “Jesus Christ”.

Yahweh judges “The Christian Nation” out of which He is to elect/select/choose His “Early Adopters” (Matt.20v16, 12v14, etc.) and it is JCg, together with these “Early Adopters” who are to judge “The 3rd Epoch Israel” (= “The Resurrected World”) in The Millennium (John.5v22,27,30, Matt.19v28, 1Cor.6v1-3, etc.).

We must behave correctly with “The Responsibility” that comes from being entrusted with “The Knowledge” that “1st Century Christianity” delivers to us, through JC as “The Word of God” (Rev.19v13).

The religious leaders are demonstrably not exercising the correct “Responsibility” with God's Word (as opposed to what JC and the Apostles taught us) and the devotees are not learning how to be “Responsible” and cannot become “The Future Heirs over The Resurrected World” (Matt.25v20-23, Luke.19v16) because they are not correctly instructed by their leaders

Thus, both the leaders and congregational members are rejected by Yahweh for “Sonship” (requiring “The 144000 Trigger Threshold” [Rev.14v1-4] to occur), thereby personally delaying the onset of The Millennium, and are thus personally continuing the present pain and suffering within The World today (Rom.8v22)!

We must not use “The Word of God” as a tool to extract any form of worldly return from the people looking up to “us” for guidance. “The Knowledge” must be used to edify people (not having “The Knowledge”) around us, and not to hold people into a position below us 'supposedly having The Knowledge' so that we (with “The Knowledge”) can self-indulge by keeping our neighbour in an uneducated position below us!

Then we look around us today, at our leaders of today, the worst offenders being leaders of “Religion” who are doubly culpable, because they (1) pretend to have “The Knowledge” so that (2) they can physically gain out of their deluded devotees by keeping them in “darkness”.

I use the word “pretend” because what they deliver as “Religion” is not testable within itself, in our present existence, and thus they remain 'safe' from reasoned external questioning by hiding within a 'bunker-like' mentality. “1st Century Christianity” correctly taught and understood, blows “Religion” asunder, and hence The Leader of “The Established Religion” of JC's day convened a meeting having only one item on the agenda: JC's teaching of “1st Century Christianity”, as we are told at John.11v47-53. An event repeated throughout “Religion” across The World whenever the essence of “1st Century Christianity” appears during The Gospel Age (an example of this would be William Tyndale).

“1st Century Christianity” teaching unmasks “Religion” to show that in reality, “Religion” as it has been taught and practised is entirely parasitic to society as regard to “**The Salvation of Mankind**”.

Which makes for an interesting observation, because that subject is supposed to be its reason d'être!

That is specifically why increasingly educated 'secular people' who may have had any previous regard for “Religion” are now leaving “Religion” in their droves at “The Close of The Gospel Age” (Rev.18v4), where “Religion” is becoming an embarrassment to a sane/reasoning, educated mind! To become a mere “by-word” (Deut.28v37, 1Kings.9v7, etc.).

Made so by “Leaders Religion” teaching “unrighteous, inane nonsense” (when carefully analysed)!

The Crux of the matter being:

It does not matter whether a person is “religious” or not, an individual's outcome is only dependent upon how they truly behave to their neighbour – over what is to be a 2 part physical and 2 part spiritual life.

This is the crux, – “Religion” today in all its forms is an irrelevance to society, and the 'professional religious people' have only one vestige interest in maintaining “Religion”; it becomes the preferred means to their 'bread and butter'!

They absolutely cannot be objective – and moreover, these people become “leaders” because they like what the practice of “Controlling People” brings to them – rather than be edifying people for the future well-being of society.

That is how “1st Century Christianity” is so very different to “Religion”.

Let me finally propose this possible scenario?

What if:-

Yahweh has achieved His 143999 TCs who have personally proved themselves worthy to The World as future rulers. He requires only that one more person to fully demonstrate to The World that this last person is worthy to become the 144000th person to fully complete “The Prophesied Trigger Threshold” to bring forth “The 1st Resurrection” - and moreover, that person could be: “**You**”.

“You” have all the head knowledge – thoroughly knowing The Bible.

“You” thoroughly understand Yahweh's Word and accurately teach what it means to your neighbour.

“You” operate in true charity – freely giving your time and energies to truly edify your neighbour.

“You” take absolutely nothing off your neighbour – because of personal secular employment.

“You” are outwardly operating, as did JC to his local community in his teaching of God's Word.

Yet there is one thing missing – that stops Yahweh from accepting “you”, and thus “you” are personally delaying the onset of “**The 1st Resurrection**” which means: The World must plunge ever further in its decay.

Throughout the layers of “Mankind”, leaders of whatever layer are behaving as tyrants, plundering the innocents, disease and famine further spreading 'their fingers of hurt' throughout The World, animals also suffering despicable living conditions under the subjection of “Mankind” – all this for at least another day – after yet, another day!

All this is occurring throughout The World because of one reason only:-

All because of “**You**”!

“You” are not proving yourself as being quite ready to rule The World as a future “son of God” for one reason or another – being a condition as seen by The World, and yet, not by yourself.

Perhaps it may be (Luke.6v41-42):

The rejection of being absolutely humble and contrite of mind to “Authority” (Rom.13v1-6).

The requirement of reconciliation to a single offended person.

A close family member sees you as being 'not like Jesus' because of some reason (1Pet.2v21-24).

Alternatively:

Any other reason outside the above listing that sadly holds Yahweh back from selecting “you” to complete 144000!

Furthermore, “Creation groans” (Rom.8v22) continuing to wait ever longer until a perfected minded person is ready to take the last 144000th place (Rev.14v1-4).

Where this means - I repeat:

The World must continue in its pain “groaning in its suffering” because of “you” being unrepentant in some manner.

What does this mean to “you”?

That YOU are personally holding back the fulfilment of Yahweh's Desire.

Where, “you” are deemed by Yahweh as being “adversarial to His Desire being fulfilled in The Environment”.

Consider very carefully this possible scenario – because at some time in the future – it will occur!

Let not it be “you”!

This is The Crux of: “1st Century Christianity”!

This is such an important topic, which explains the urgency now occurring at The Close of The Gospel Age.

Now I shall introduce the reader to “The Villains of the World” in my next article entitled:

Why does Yahweh detest Leaders of Christendom?”

This is my largest writing in my series of seven expositions, because they have so much for which to answer!
