

## Who Does Yahweh Really Want?

It can be simply answered by stating:

Only those people who fulfil His Desire!

His Desire is to yield "A Perfected Society" into The Culmination.

This "perfected society" that shall have **no** pain or suffering for **any** of its members!

We now have the answer – simply defined, and yet presently, we are a 'million miles' away from that ideal state!

So how do we **righteously** get from "here" to "there"?

The key word is "Righteously" because it must be seen by **every** human who attains this marvellous goal, that:

All humans who failed along the way (and thus, they never achieve Yahweh's "Ideal Goal for each one of us", noting Yahweh's view on this matter at Eze.33v11, 2Pet.3v9) - having been permanently removed (unto a non-existence = personal annihilation), of which they freely choose to do this upon themselves when:

Having all the information and personally experiencing "Paradise", rejected it, having preferred their old self!

This is the definition to "Righteousness" in relation to Yahweh (as a Neuter), inasmuch **It**/(He/She) has 'bent over backwards' give "The Intrinsically Ideal/Good Existence" for **any** individual into The Culmination, and yet it was rejected, because the person freely chose to be "Iniquitous" once having **all** "The Required Knowledge" upon which to make an educated decision.

So clearly, that 'life-changing' decision cannot yet be made (irrespective of what our religious leaders may state)!

"Iniquitous" means: "The person knows what is wrong, but freely continues to sin because they like sinning."

Clearly stating, "The Requirement" is:

"A complete personal mind-change away from where we are today" and "wholly imitate Jesus Christ".

Let me repeat:-

So how do we **righteously** get from "here" (worldly methodology) to "there" (Yahweh's Methodology)?

"The Most Important Thing" of which I cannot overstress, even if I repeat it a hundred times in succession is:

To absolutely and completely REMOVE out of our mind what "Professional leaders of Religion" tell us!

I do not care what "Religion" it is, I am speaking about **ALL** "Religion", because quite simply, "Religion" itself does not fulfil what I stated earlier:

"Yahweh must be seen to be wholly Righteous into The Eternity by all entities existing into The Eternity!"

"Religion" absolutely does not offer that scenario – and thus must be rejected because it does **not** accurately represent "The Almighty God's view" on things that are ultimately, to righteously operate in The Universe – being His Domain! (I shall use the male pronoun for Yahweh; this just makes the text easier to read, even though "It" is most accurate.)

Who am I to make that statement? What do I know? What are my credentials?

Quite simply I make the following statements:

**Firstly:** Only "1<sup>st</sup> Century Christianity" as taught by Jesus Christ (= "JC", from now on) and the 1<sup>st</sup> Century Apostles is "Righteous" by Yahweh's Definition. Without any doubt, "Religion" is **NOT** "righteous".

I thoroughly underwrite this declaration with much reasoned evidence - as given elsewhere.

**Secondly:** "1<sup>st</sup> Century Christianity" is **NEVER** taught today, nor has it been for the last 1700+ years!

**Thirdly:** I have consumed some 50,000 hours of my personal time in studying **only** The New Testament, together with The Bedrock of The Old Testament, and absolutely **not** of Man's wholly erroneous ruminations! So that my mind is now clear on God's Word, and **not** cluttered with the nonsense 'exegesis' sourced by Man (noting Paul's comment at Gal.1v10-12)!

**Fourthly:** I have **not** been paid to do this, it has been solely done 'out of hours'. Quite simply I am **not** a "Professional leader of Religion", but a "Professional Engineer of Electronics" (that sources my income). This means **if** I choose to be objective, **then** I can be objective, not falling afoul of Matt.6v24, 22v20-22.

**Finally:** After 60+ years, I have been in the 20 year revolving door, generation after generation, and have seen the **same** things occurring again and again. At my age I know precisely how the minds of the worldly leaders of Politics, Religion and Commerce operate behind their professional 'polished endearing smile' for a worldly income, being "**the stink of corruption and hypocrisy behind it**" (Matt.23v27-32).

Just read a few issues of "Private Eye" to endorse what I state, – and that is only the tip of the iceberg!

From the above, it can be seen that:

**If** I have **no** motive to "Spin the Truth" for some ulterior motive,

**Then** what I deliver is more likely to be trustworthy – because what else is my driver (if my profession of "Electronics" pays for my fleshly existence, and I have absolutely **no** desire "to control people" for any further worldly gain)?

I have absolutely **no** reason to state "religious pronouncements" to charm a large section of The Public to become "Attracted to me", because I have no need to be paid by The Public in some means or other for example:

Money, Power, Leverage, Honour, Glory, Pension, Sex, etc. (of '1001' things, that becomes a worldly driver).

We know this maxim is true "The people, who pay The Piper, call the tune"!

Thus, **if** I am motivated to accurately represent Yahweh's Interests - because of what God's Word has taught me, **then** I shall do it without the hindrance that comes from worldly sources to distract me (Matt.13v18-23).

I have only written the above to express: "**My Credentials**" to underwrite what God's Word teaches "us" to ultimately yield "The Perfect Society into The Culmination", but is yet **NEVER** taught by "Religion"!

What I shall write is only what JC taught us, being an extension by means of "Answer" of what The Prophets taught us!

It shall **not** be what The World wants to hear, principally “**not** what Religious People want to hear”!  
In fact what I carefully explain later will be far more endearing to 'outside' “sincere atheists” (hence Luke.5v35-39), but **not** to the 'inside' “hypocritical atheist”, a truism of most “professional leaders of Religion”, made so by what they have learnt at seminars, (from Matt.23v15).

Why?

Because “**Religious People**” have wholly closed their mind to “**Reason**” and “**Common sense**”!

They have been taught to become like this by their “Religious Leaders”!

They think their little group is correct, and all people outside are wrong (a decision often based upon 'zero' evidence, but only untestable “**hearsay**”) because their religious leaders have taught them: “Not to think”, and thus **not** to become dangerous to “These Leaders”, because ‘corralled unthinking cattle’ are always easier to farm than 'thinking animals'! But the 'outside' “sincere atheist” is prepared to: 'Look at anything' (because intrinsically, they internally wish “death” does not personally end everything, and if there is something sensible on the horizon, then they will investigate it)! Sadly “Religion” does not deliver “sanity”, but “insanity” to many of the deluded devotees, as we can witness throughout both “time” and “society” (do I really need to give '10+ pages' of one-line bullet point examples?). Therefore, we must reason: “Religion” can only be sourced by “The Opposer/Adversary” (= Satan, through his representatives 2Cor.11v13-15) to Yahweh, because Yahweh does not desire to deliver “insanity”, but only “sanity” into “The Culmination within Perfected Society”!

Surely “religious people” do not desire to be “insane” for an eternity?!

Some examples of “insanity” would be:

Speaking gibberish (supposedly in tongues), rolling around in the dirt (supposedly slain in the spirit), inventing numbers out of the Bible (for example “444”), ridiculous repetitive numbers (supposedly like 'a code'), etc.

Nevertheless, they must be 'insane' when they behave in such a ridiculous manner by a few given examples above, and yet JC taught “sanity” through careful exegesis based upon The Old Testament, so we are all able to personally discover “The Disclosing Truth” over what shall become our 2 part physical life, made possible by his ransom sacrifice.

Thus, JC gave “The Knowledge” on how to personally succeed, and importantly, “The Instruction” on how to avoid “Religion” by examining its fruitage (Matt.7v16-19) and of what it erroneously teaches (hence the advice to leave it, Rev.18v4, recorded in John's vision of JCg).

Therefore, I repeat “The Question” of The Title to this piece:

Who does Yahweh really want?

Again, quite simply stated:

Yahweh wants people who fulfil His Desire (to yield a Perfect Society in The Culmination)!

But I have shown (and much more so, on “FutureLife.Org”) that “Leaders of Religion” and their followers do **not** fulfil His Desire (during the 1<sup>st</sup> part of their physical life), and many religious people most certainly would not contribute to a perfect society (in their present state), where by contrast, many atheists do their best to yield a perfect society. The Bible actually teaches us that “Good People” are not necessarily “Righteous”, but only those people who fulfil Yahweh's Desire (Rom.4v1-5, Hebrews chapter 11, noting specifically 11v38-40).

So how do we fulfil Yahweh's Desire to enable “every possible person” to have “every opportunity reform”!

The Crux of this reasoning is that:

Every person must have “every opportunity to **personally reform**” when given “**The Knowledge**”.

And this is absolutely impossible for virtually all people during their present life, because as The Bible teaches us, all these people are against what Yahweh truly Desires to occur (John.17v14-16, 18v36) - so we rationally reason that what Yahweh truly Desires just cannot occur during this present system, that has operated during the last some 6000 years. So, we may accurately reason:

If a perfect society has not occurred in the last some 6000 years over so many generations where the members of society take their respective slots within society to continue the one/same methodology as always in each generation (with increased technology that can be misapplied to produce more pain more quickly).

Then “nothing will change” – except with “greater the power (through the use of technology), then greater the subjection” to yield “greater pain throughout society” (e.g. Internet yielding phish/scam/hack/trolls/stalkers, and software application programs taking twice as long to run because of the anti-virus protection required)!

Therefore, we have two reasoned scenarios:

1. Yahweh desires to produce a perfect society (and He will achieve it in the most-righteous manner).
2. Based upon Mankind's provenance, nothing will change, but technology 'ramps up the gain' for more instability

The Bible tells us there will be a complete regime change in the near future away from “The Present Worldly System” unto “The New System” only made possible by Yahweh through JC (Luke.19v14, 2Pet.3v10-13, Dan.12v11-12, Rev.19v15-21, 20v1-3, 21v1-4, etc.).

But we also know that people do not 'change over-night' - and thus righteously require “time to reform”\*, where this personal reform must be internally driven, having been trained to gain “The Knowledge” from an external influence to source the required guidance and direction.

We have read from The Bible there is to be:

“The Regime Change”.

Therefore, we may ask: “Who is going to lead it?”

The Bible tells us there shall be unique people positioned as kings/priests/judges (2Tim.4v6-8, 1Pet.5v4, Rev.1v6, Matt.19v28, 1Cor.6v1-3, etc.) elected specifically by Yahweh (Matt.20v23) to be ruling alongside JCg to ensure

“Righteousness” is maintained throughout The World (Rev.2v27, 12v5, 19v15).

How many shall there be of these unique people?

The Bible specifically tells us at Rev.14v1-4 there shall be 144000 individuals as “The First-fruits”, being “a few in number”, elected by Yahweh (Matt.20v23) from out of “a very large quantity of people” (Matt.20v16, 22v14) who shall be elevated into this position of rulership. These individuals become “The 144000 First-fruits” as “The Early Adopters” elected from out of the some 3 billion Christians living during The Gospel Age. This leaves “The ‘Unelected’ Christians” and all “non-Christians” who themselves, require this future “New Regime Change” within which to righteously purify themselves, to be taught by “**The Early Adopters**”. Where it is “**The Early Adopters**” who have previously, righteously perfected themselves upon “The Word of God” (= JC, Rev.19v13) during the 1<sup>st</sup> part of their physical life (= during The Old Regime of Satan’s authority/methodology operating over The Earth of some 6000 years). All that is but the barest of over-views, but wholly supported by thousands of prophecies and allegories of which our worldly Christian leaders could recognise, yet they “**choose not to know**” or “**prefer to remain ignorant**” (“agnoeo” Strongs<sup>TM</sup> = 50) because it would require a complete mental overhaul away from what the present worldly methodology comfortably yields to them.

In fact, the professional scholars/theologians work over-time to find every implausible excuse so as “Not to believe”. Our next logical question should be:

To get this whole plan “off the ground, to make it fly” then how is Yahweh to operate?

I cover in very great detail all the finer operations of this, but most importantly Yahweh must be seen in The Culmination as to have operated during each and every step in “The Most Righteous Manner”. Else, if “The Procedure” was not entirely “Righteous”, then there will always be some entity who could call: “Foul”! Even if it was only Satan (as perhaps a death wish, to unsettle the minds of future survivors) just before Rev.20v10 occurs! This call of “Foul” shall never occur – and thus “This Plan” must be wholly: “Righteous”, and absolutely not be “unrighteous” in the myriad of ways that “Religion” sourced by Satan generates within its ‘exegesis’ (if to say, that some religious sects have any ‘exegesis’ at all within their utterings, except all to be unsupported and unreasoned “hearsay”!).

As I state, Yahweh chooses specific people to represent His interests.

Absolutely contrary to what is insinuated by leaders of Religion in their “sales spiel”, Yahweh will wait for these specific individuals to prove themselves over many years (to The World) before He hands them “**The Responsibility**” of any form of commission (see the background of Abraham, Isaac, Jacob, JC, Paul, Timothy, etc.,) noting the comment at James.1v6-8.

I must state for The Record:

It will be most difficult to fulfil Yahweh’s Desire “Precisely So”; and so very easy to personally “Mess it up”. Moreover, by easily failing (as do most Christians [of the ratio, 144000 passing compared with 3 billion failing] Matt.20v16, 22v14) shows to The World that our present presumptuous representatives (supposedly of this future New World) are not worthy (if having falsely represented Yahweh in the 1<sup>st</sup> part of their physical life). This would automatically fall afoul to “The 1<sup>st</sup> Requirement” of “Righteousness” if the vast majority of supposed representatives are not able to “Put The New World Order Together” because Luke.17v21 is not occurring!

This is naturally contrary to what “Professional Leaders of Religion” will teach us, because of the following:

1. They have taught of a “**New Jesus**” for the last some 1700+ years (2Cor.11v4).
2. To become a “**Gospel of Excuses**” (Jude.v4) so that we can remain “human” (and still keep the money rolling in).
3. To oppose Yahweh from obtaining the 144000 future world leaders for The Anointing (hence 1John.2v18-19, 4v1-3)

This forces Yahweh to operate a parallel plan outside the operations of “Professional Leaders of Religion”.

This “Parallel Plan” requires “The Early Adopters” who personally reject Satan’s present tenure over The Planet! Yahweh begins by choosing “The Ancient Worthies” and “The Prophets” (as given in The Tanakh [= The Old Testament of The Bible]) to “Set The Scene” and “Make Possible The Scene” in “The Most Righteous Manner” – so that no human can find fault with them (Heb.11v38-40).

These people laid down “What was to Occur” both by prophecy and by “The Personal Righteousness Demonstrated” that effectively underwrote “The Prophecy” made.

It is most important to understand “That Subtlety” to righteously substantiate “The Original Prophecy”.

“The Scene” was laid out – for JC to come and “Fulfil The Laid Down Prophecy” that “must be righteously fulfilled”, to underwrite by “Answer” “The Original Prophecy” (Gen.3v15) proven perfect against “**The 1<sup>st</sup> Covenant**” based upon: **The Works**” given by Moses (in Leviticus, which JC answered at Matt.5v16-18, noting John’s very important observation/comment at Matt.3v14).

Therefore, JC became “The Means” to righteously inaugurate “**The 2<sup>nd</sup> Covenant**” based upon: **The Mind**”, being something that we could all pass (when educated), even though we could never pass “The 1<sup>st</sup> Covenant” (Rom.3v23). “The 1<sup>st</sup> Covenant” was only inaugurated by Moses as being “**The Standard**” for “JC to Pass” being “The Goal” for “The Righteous New World” - hence showing “The Requirement”.

However, for JC to have met that “Requirement” of “The Standard” in his life during his assay/proving for a period of 3.5 years (hence Matt.3v15) that led to his assassination by “The Professional Religious Leaders” ‘putting a gun to Pilate’s head’ (John.19v12) then he needed to have “The Correct Methodology” operating within his mind.

JC had “Yahweh’s Methodology” operating within his mind (= “edify our neighbour to our own hurt”) and thus repulsed “worldly methodology” (= “self-indulge to our neighbour’s hurt”).

Because of this, then he was positioned to righteously establish something that we could then pass by imitation (of

“The 2<sup>nd</sup> Covenant” as laid down by JC), being it is worldly methodology that presently controls our mind, which must be wholly reformed to become successful in “The New World Order” of “Yahweh’s Methodology”.

Noting, “The Body (outputting works) is controlled by The Mind”, thus:

“Get The Mind correct and then the correct works will follow”.

Let me quickly explain how we fail “The 1<sup>st</sup> Covenant” and are yet able to pass “The 2<sup>nd</sup> Covenant”.

We are naturally selfish, being as a child viewing things: “give me this”, and reasoning, if I cannot have it, then I will take it regardless of the consequences. We must learn, “The Consequences” of our self-indulgent actions hurt the recipient, and in the long term the perpetrator, having a 'screwed-up mind' following this methodology certainly cannot yield a perfect society – so we need to travel righteously from a positional stance of A to B.

“Education” based upon practical experience gets us from A to B, this is called “**learning by experience**”.

Thus, JC through his ransom sacrifice enables us to get from A to B in a “Righteous and Lawful Manner” (as regards Yahweh’s “Universal Law on Sin” that must be observed for “The Perfect Society” to exist in Yahweh’s Environment of The Universe for an Eternity. Thus, educate our mind so that “The Decision for Life” now depends only upon **The Mind** and not upon **The Works**, that shall then underwrite this future scenario and requirement.

How so?

Being “human”, we all make mistakes while we learn, even when having “learnt”, then the odd unforeseen mistake will occur - it is called “an accident”! If we were always to be judged upon **The Works**, then ultimately all people would be annihilated in due time by their “accidents”!

However:

**If** humans are judged upon **The Mind**, which has learnt to be perfected upon “Agapao” (= “to edify our neighbour to our own hurt”) **and**:

**If** we accidentally sinned in works while still being driven by “Agapao”,

**Then being judged upon “Agapao”** (of The Mind) we can survive as though ‘having not sinned’, even though our works had failed (by accident) by virtue the sin was not premeditated (because how could it be, if the mind was driven by “agapao”?).

As I stated earlier:-

People are only “Righteous” if they “wholly fulfil Yahweh’s Desire”.

Yahweh’s Desire is now (during The Gospel Age):

“To righteously increment forward Mankind’s Salvation”.

Yahweh **first** needs His demonstrably “Righteous” representatives (who exactly imitate JC’s ministry/lifestyle) Where, The Mind (of agapao/{edifying love}) drives these representatives’ output (in agape/charity).

When the number becomes 144000 in total then this becomes “The Trigger Threshold” for “The 1<sup>st</sup> Resurrection” When “The 1<sup>st</sup> Resurrection” occurs, then “The Wheel starts turning” and the other prophecies can be fulfilled.

The other prophecies being:

1. Jc’s return with 144000 TCs (Rev.19v16-21), to remove all worldly operating authorities.
2. Satan can be restrained (Rev.20v1-3), thereby righteously bringing to The Fore: “Yahweh’s Methodology”.
3. 1000 year (Millennium) is a period where society shall learn how to be purified (Rev.20v4-7).
4. Satan shall be released (Rev.20v7) to become “The Catalyst” to separate “The Good from The Iniquitous”.
5. Satan is removed (Rev.20v10) having forced “The Divide” (Matt.13v30) and hence (Rev.20v11-15).
6. “The Good” people continue in the 2<sup>nd</sup> part of their physical life having personally purified their mind (in 3)

That is precisely what The Bible tells us, and yet is **NEVER** taught by leaders of “Religion”!

The do not teach it, because quite simply they do not “Want to Believe it”, else (1) all manner of self-correction is required and (2) they ‘do not want to teach themselves out of a worldly position and what it self-indulgently brings’!

It is for these self-same reasons as to precisely why “The Leaders of Religion” behaved as they did with “The Word of God” (= JC, Rev.19v13) at John.11v47-53.

As I state elsewhere, Professional Leaders of “Religion”:

1. Are rejected from Sonship (as judged by Yahweh), because they behave hypocritically (Luke.12v1).
2. They would be rejected by the then Educated World – if they taught: “The Disclosing Truth”.

Because “The Educated World” would know, that “**Universal Salvation**” only occurs:

1. Through **JC’s Ransom Sacrifice** to righteously get us into the 2<sup>nd</sup> part of our physical life (1John.2v2).  
(This is done by **Yahweh** – inasmuch Yahweh resurrects us into “the 2<sup>nd</sup> part of our **physical** life”.)  
(We are given a perfected DNA fleshly body in trust for us to commensurately purify our minds.)
2. Through **JC’s Ministry** to purify our mind upon “The Word of God” (John.3v16).  
(This is done by **Ourselves** – inasmuch we must wholly hearken to “The Word of God” = believe in JC)  
(To “believe in JC” means: “think like JC, and precisely imitate his deportment” [1Pet.2v19-24].)  
(This is the stage where we personally purify “the 2<sup>nd</sup> part of our **spiritual** life”.)

So I may ask:-

Can the reader see “**Religious Leader**” mentioned within the above listing (of JC, Yahweh and Ourselves)?

Where “The Religious” leader should be precisely imitating JC’s ministry/lifestyle (1Cor.3v16, 1Pet.2v5-9) by

(1) teaching “1<sup>st</sup> Century Christianity” and

(2) be giving freely for absolutely no worldly return (by being “The Last/Least within The World”.

[Matt.19v30, 20v16, Mark.10v31, Luke.13v30, etc.], to be as “The Scum of The Earth” [1Cor.4v13]).

However, The World can see this requirement does not occur within “Religion”, especially the higher the leaders climb

within their worldly establishments, and thus we are back to the earlier listing given to specifically “leaders of Religion”.

This is all precisely as The Bible tells us (underwritten by my citations) – I have invented nothing! Nevertheless, this is hardly what we are likely to be told by “The Representatives of Christendom!”

What is the point of my ‘attack’ upon “Leaders of Religion”?

The point of this “**reasoned observation**” (as would be given by a reporter and is not an “attack”) is to endorse precisely what The Bible teaches us about “**The Real Goal**”, which is: “To further Yahweh’s Desire to bring forth The Salvation of Mankind”.

Surely, this is what we ‘all’ (should) want?

“Leaders of Religion” are **actively delaying** this most marvellous future for Mankind under Yahweh’s Regime!

They are thus: “Personally prolonging Mankind’s present pain and suffering under Satan’s Regime”!

Let me explain myself - by going back to the title of this dissertation:

**Who** does Yahweh want?

Being: “Who does Yahweh want during The Gospel Age?”

The answer is quite simple:-

Yahweh wants His future 144000 “Sons of God” elected from out of “The Christian Nation”.

These are unique individuals who “precisely imitate JC’s ministry/lifestyle in arduous personal sacrifice!” (Matt.10v39, 16v25, Mark.8v35, Luke.9v24, John.12v25, etc.)

We realise that **if** there are some 3 billion Christians over these 2000 years and only 144000 individuals are deemed by Yahweh as having precisely achieved “The Goal of Sonship” **then**:

“Only a few have been elected (to be sons of God) from out of the very many invited (to be sons of God)”.

Precisely what The Bible teaches us at Matt.20v16, 22v14, 7v12-14 (and yet again, **never** taught within Christendom). Has Luke.17v7-10 ever been taught to congregations?

I suggest “Never” for the last some 1700 years, except in an opposite sense!

The point of all this is: “The Exhortation” (constant within The Epistles) to **personally strive for The Goal** and absolutely **never** leave it up to someone else to do it for you, to be paid by offering a worldly service for a worldly mind!

This is my exhortation:

“The Window of Selection” is very, very tight to achieve “**The Goal**” (Matt.7v12-14).

This is the absolute opposite to what worldly Christian leaders teach!

They make “The Invitation” to become so wide and so very enchanting, so that we can become “One of The Many” people (Gal.3v1, 1Thes.2v3-6, etc.), but then they “keep The Masses in that state” so the devotees can be milked in a worldly manner by their “over-lords”!

“The Over-Lords” absolutely do **not** want “The Masses to become accurately educated upon The Word of God”!

They want to keep them ignorant of what Yahweh truly Desires, and thus fill their minds up with customs, rituals and myths (Matt.23v23) to occupy their time (so that they do **not** become “Responsible to The Requirement” that “The Word of God” demands from those people personally, “actively seeking” to fulfil Yahweh’s Desire [Matt.7v7-8]).

Yahweh is seeking out people who honestly: “Run with The Word of God” (1Cor.9v19-23).

Yahweh demands people to “Precisely Imitate The Department that JC laid down” as “The Primary Reference”!

We must take upon ourselves: “Accountability, Ownership and Responsibility” for “The Word of God”.

For us to fulfil Yahweh’s Desire then we must become very well educated in “The Word of God”.

Absolutely do **NOT** go to a seminary, else, you will learn how to fulfil Satan’s desire “**To Oppose**”!

(Noting Matt.23v15 compared with JC at John.7v15, the apostles at Acts.4v13, and what Paul was like before JCg personally intercepted him, Acts.9v5).

I explain everything to the very lowest level elsewhere on my website: “FutureLife.Org”.

The Crux of all this is that “Professional Leaders of Religion” do **not** behave like JC and The Apostles, but only in a hypocritical sense (Luke.12v1) because they have not changed their mind (2Tim.3v5, Tit.1v16). Hence, they **cannot** be fulfilling Yahweh’s Desire to increment forward The Millennium, and their devotees likewise are rejected for “Sonship”, because they are **not** actively encouraged to take upon themselves “Ownership, Accountability and Responsibility” with “The Word of God” to precisely imitate JC’s ministry/department.

And thus “The World” still “**limps on**” in this “**Continuum of Religion**” that occasionally ‘spits out’ “**The Early Adopters**” of “The Word of God”. These “Early Adopters” are sincerely driven internally, and **not** driven by The World paying for their ministerial services, but they truly “Teach The Word of God” for absolutely no return except “abuse” perpetrated by leaders of “Religion” (after JC, John.16v1-4, 2Tim.3v11-13, as received by William Tyndale, etc.) as we have witnessed throughout Mankind’s history. Precisely so as for The Prophets before JC’s 1<sup>st</sup> Advent, (Matt.23v37, Luke.13v34). However, naturally, each succeeding generation of religious leaders would state: “We would not partake in such enterprises!” Matt.23v30, and yet they do precisely the same (certainly **spiritually** [by killing off people’s opportunity for Sonship hence “Anti-Christ/Anointing” 1John.2v18-19, 4v1-3], if not also **physically** in some clandestine manner, John.19v12).

Why these hard-hitting accusations?

Because I truly care for Mankind’s Future and I want The Millennium to come as quickly as possible!

I want a **new** “Ruler of The Heaven” (singular, hence “local Authority to The Earth”).

I want the present **despotic** “Ruler of The Heaven” (Rev.12v12, 1John.5v19, Eph.2v2) removed as quickly as possible.

I want Yahweh as “The Ruler of The Heavens” (plural, hence Universe) to Rule through His son JCg over this world.

The above is **not** going to occur soonest, when we have our professional leaders of “Religion” **actively delaying** “The

Onset” of “The 1<sup>st</sup> Resurrection” by impeding people (Matt.23v13) from becoming truly: “Children of God”. This means, “Impeding the Anointing” of the 144000 TCs and thus they are behaving as “The Anti-Christ/Anointing”! Where a “Child of God” is (and can) only be determined by Yahweh (Matt.20v23, noting 1Sam.16v7-13 for the context of “Kingship”, noting the relevance at 2Tim.4v6-8, 1Pet.5v4, Rev.1v6).

By contrast, to what The Bible teaches us, we have our “Professional Leaders of Religion” errantly state that: They and the devotees are supposedly already “Children of God” (insinuating they have no need to improve) when they do not “precisely imitate JC’s ministry/lifestyle”!

That is wholly misrepresenting Yahweh’s Interests!

Yahweh’s Interests are:

Gain His “Early Adopters” (from out of Satan’s 6000 year tenure over The Earth) as “The First-fruit Harvest”.

Gain His “Late Adopters” (from out of JCG’s 1000 year rule over The Earth) as “the Main Harvest”,

Where JC is The Lord of The Sabbath, and The Sabbath was made to (purify) Men (Mark.2v27-28)

And The Day of The Lord is as a thousand Man Years (2Pet.3v8), of which JC covered in his death (John.19v31, 20v1)

Yahweh’s Rest is on The Seventh Day of Completeness/Perfection by Oath (Shaba/Sheba, Strongs<sup>TM</sup> = 7650/1),

as we are told at Heb.4v4 in its all-important context.

It is interesting to make this comparison:

Secular science-based occupations are substantiated by:

Demonstrable precision and exactitude given by assay through examination.

This approach is completely counter to that demonstrated in “Religion” which is ‘supposedly supported’ by untestable “hot air and vacuous hearsay” created by spiritually blind peers before them (Matt.15v14, Luke.6v39) leading to “zero precision”, where everyone can think exactly what they like – counter to “The Perfect Standard as precisely required by Yahweh” to yield “A Perfected Society into The Culmination”!

That is “**The Basic Problem**” professional leaders of “Religion” have; they need to pretend that what they

know ‘is valuable’, because what else do they have ‘to help edify society’ - from which to take a fleshly living?

This is specifically why The Bible speaks of “The Babes” fulfilling Yahweh’s Desire in their own respective manner (Psm.8v2, Isa.3v4, Matt.11v25, 21v16, Luke.10v21).

What does this term “The Babes” really mean?

It means these specific people have not gone through “The Worldly Religious Route” (John.7v15, Acts.4v13) through seminaries to become supposedly “Mature in (worldly) Religion”, but by contrast, these specific people (The Babes) have taken it upon themselves to personally study The Bible because they are internally driven to discover what Yahweh Desires (Matt.7v7-8). This is in direct contrast to “professional leaders of Religion” who become all knowledgeable in “All things of Man” (being everything dreamt-up by their spiritually blind gurus/sages of old, Matt.15v14, Luke.6v39) taught by teachers, most of whom do not sincerely wish to promote Yahweh’s interests, but only to maintain a fleshly income through “Religion” (noting Luke.16v3).

Professional Religious Leaders are taught in seminaries to irrationally contest “The Word of God” (in a worldly manner, falsely believing to be personally sophisticated and all knowledgeable).

Quite simply: “They just do not get it!”

By contrast “The Babes” have zero knowledge of “Religion” (being sourced by Man) and yet have extensive knowledge of “The Word of God” which they fulfil by being “Lay-Preachers” giving their time freely for absolutely no worldly return. Their fleshly income is derived only from their secular occupation (hence these people are wholly objective in what they do, not contravening the warning given at Matt.6v24, 22v20-22)!

Lay-Preachers are internally driven in their private homes to rationally assay/test/prove “The Word of God” (in a Godly manner, in true humility to gain **assurance**, of which they practise in **fidelity**).

This is further supported by “The Widow and The Rich Men” giving their dues in The Temple (Mark.12v42-43, Luke.21v2-3) being that “The Lay-Preachers” give out of their livelihood, but “Professional leaders of Religion” give out of their excess (inasmuch they are paid to deliver what they give)!

Repeating the maxim: “The Person, who pays The Piper, calls The Tune” (2Tim.4v3-4).

**Most** of JC’s parables teach of this rejection by Yahweh of “Professional leaders of Religion” to a position of Sonship!

Please read my many hundreds of inter-verse commentaries of The Four Gospels that fully explain JC’s teaching. JC teaches us by allegory that professional leaders of “Religion” have the one/same mentality throughout **all the ages**, generation after generation Matt.23v37, John.11v47-53, 16v1-4, of which we read at Acts.4v2-3, importantly Acts.4v26-27, 5v18, 6v12, 7v58-60, 8v1, 12v5-6, 13v27-28, 13v45, 13v50, 14v19, 20v29, and many more citations could be used. Then we only need to look through “The Recorded History of The Christian Church” throughout The Gospel Age, with my notable example William Tyndale to realise that “The Thought Processes” are exactly the same within these leaders of “Religion” (hence Rom.1v16-32)!

“The Call” of this dissertation is this:

Yahweh demands that “**YOU**” “The Reader” should renounce “Religion” (Rev.18v4) and take up “The Full Armour” supplied by Yahweh at Eph.6v11-17 to become a “Soldier of The Anointed” by precisely imitating JC, then perhaps/maybe/possibly you could become a future “Son of God”!

There are still places at 2016 CE when I wrote this piece.

So, after stating Yahweh’s plan, then people may ask of me:

Are you one of those 1440000 TCs?

To that question I will reply, I truly have not the faintest idea, ONLY Yahweh makes that decision (Matt.20v23).

He perhaps/maybe/possibly could find something within me that could make me worthy of that position, perhaps/maybe/possibly there is something within me that makes me **not** worthy of that future responsibility and I shall be rejected.

**Despite all of this**, most importantly it **is** my responsibility as a minimum to fully reciprocate “to the very best of my ability” my appreciation of what JC did for us in the best possible manner, which is to precisely imitate him “to the very best of my ability”. Notwithstanding, I am not so spiritually blind as to realise that I can see many things that could certainly preclude me from being a future son of God. I just do “the very best I can”, I must aim for “The Goal to fulfil Yahweh’s Desire” and leave my future in Yahweh's Hands.

However, I certainly do not have the presumptuous audacity and gall to daringly call myself a: “Child of God” as do our very worldly Christian leaders presuming they are “God”, when it is **only** Yahweh Who can make that decision (Matt.20v23)! I would not dare be in their shoes during their present judgment today by Yahweh (Matt.7v20, 8v12, 21v41, 44, 22v11-13, 25v26, 31, 46 as a tiny example of citations that I could give). I speak in the same manner as did JC and The Apostles speak of The Pharisees and ‘The Jews’ (where “Jews” means “Pious Religious People” in the context of The New Testament, and **not** “Jews” generally).

So: “Who does Yahweh want”:

1. “The 144000 Early Adopters” of “The Word of God” elected from out of The Christian Nation during The Gospel Age, having personally demonstrated to The World they have precisely imitated JC’s ministry/lifestyle.
2. “The Reformed People from out of The Resurrected World” judged as such during The Millennium as having personally demonstrated they have learnt to precisely imitate the leaders of (1) above.
3. Noting for completeness, “The Prophets and Ancient Worthies” have already proved their worthiness to The World for elevated positions of rulership in The Millennium.

The above yields a perfected society to continue into The Culmination worthy to be added to Yahweh’s other “Creations” within The Universe!

## **Conclusion:**

Yahweh has The Whole Scenario to yield Mankind's Salvation righteously and most rigorously planned out. The Bible explains precisely how “**The Most Righteous Plan**” is to correctly operate through its various stages. Yahweh is gaining “The Administrators of This Future New World Order” **now** - who personally imbue “The Word of God” and personally fulfil “The Word of God” in their lives thereby having Yahweh's Authority (plural heavens) controlling their minds (Luke.17v21). By contrast, The World around them operates under the local authority (singular heaven) of Satan (Eph.2v2, John.17v14-16, 18v36, because of 2Cor.11v13-15 representing their self-indulgent interests). Religious leaders believe **none** of this – and only teach what gives them a worldly living for the here and now! By consequence, they cannot be objective when having a conflict of interests (and thus falling afoul of Matt.6v24) thereby demonstrating they are **not** “The Early Adopters” of Yahweh's Methodology.

How can I state that with absolute certainty?

Because (1) they teach none of it and (2) operate according to worldly standards!

### **Who Yahweh does not what for future leadership:-**

Religions Leaders who pay scant attention to The Bible, preferring to read all the supposed scholarly output of Man throughout The Generations of which they can then quote to The World! In this manner, they appear educated and thus apparently deserving of The Control over sections of Mankind, out of which they can extract a worldly living - supposedly having “Big Daddy” on their side and underwriting their behaviour! These people fail by not being objective to “The Fulfilling of Yahweh's Desire” and are thus fulfilling their own desire which is **not** the one/same as that of Yahweh, and thus they cannot have the holy spirit (as warned by JC at Matt.6v24, 22v20-22, which becomes “**a conflict of interests**”)!

Their mind has not truly reformed (2Tim.3v5, Tit.1v16), because they believe none of what they supposedly represent, and thus teach none of what Yahweh Desires to hear! Their mind is focussed upon what they can gain out of The World for their present existence, being how The World presently views their activities. They have no regard about The Millennium and how “The Extraction Process Righteously Operates”, because demonstrably: “Yahweh's Operations have no part to play within their thought processes” (as we witness by auditing their output, against specifically what The Bible teaches us)!

### **Who Yahweh desires to lead The Next Stage of His Plan in the 2<sup>nd</sup> part of their physical life:-**

People who wholly reform their mind away from worldly methodology, to become the one/same as to how Yahweh’s Mind operates.

Today, we learn of “Yahweh’s Mind” by reading **only** The Bible for our spiritual wellbeing (use a good quality Bible of pre-1950 translation, certainly **not** the NIV, which is a “bad translation”, being a “worldly interpretation”).

We learn from the examples of people's behaviour in The Bible: “What to do, and what **not** to do!”

Abel and Cain

Joseph and his brothers

Manasseh and Ephraim  
Moses and his sister Miriam  
Joshua/Caleb and the ten other spies.  
Solomon and Eli's sons  
Elijah and his servant Elhazi  
Peter/Paul and Judas

In addition, of the human sideslips (of which we must not be tempted to do) committed by:

King Saul  
King David  
King Solomon

Moreover, I could give another '100' examples where we are able to learn what we should: be doing, and, not be doing. Today, Yahweh is seeking out those specific people who do not mix The World with Yahweh (Matt.11v17, Luke.7v32). These people keep the things of Yahweh (being how Yahweh controls our mind) wholly separate from becoming "The Means" to obtain a fleshly living. Inasmuch we do not use ourselves as God's Representative "to earn a fleshly living". Importantly we use Yahweh's Methodology driving our deportment while "we earn a fleshly living" during our secular occupation, - in this manner we teach "The Word of God" through our perfect behaviour and by consequence, not behaving as hypocrites. We can then teach "The Word of God" outside our secular work, thereby "giving out of our means", rather than giving out of our excess (Widow and The Rich Men). We become wholly objective in what we do to our neighbour, having no conflict of interests, because what else is our driver, other than having purified our mind without external worldly interference corrupting our mind.

Yahweh can use these wholly reformed people for the next stage of His Most Righteous Plan.

The question is:-

Do you personally want to be part of this?  
Of what grouping do you wish to be part?  
Your future is entirely in your hands!

That concludes seven expositions of explaining what "The Almighty God" of The Universe truly wants to occur and how He is involved in making our salvation occur over what shall be a "**2 part life**" (2 part physical and 2 part spiritual). The reader can see that Yahweh's "Most Righteous Plan" is operating for all humans on this planet irrespective of what they presently believe or do within the 1<sup>st</sup> part of their physical life.
